REVISED FINAL ORDER

This cause came on for hearing before the Oklahoma Board of Medical Examiners en banc on January 19, 1985, at 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff and Jimmy Charles Martin, M.D., appeared pro se for the Defendant.

The Board of Medical Examiners en banc heard the testimony and reviewed exhibits and being fully advised in the premises the Board of Medical Examiners therefore finds as follows:

FINDINGS OF FACT

1. That Jimmy Charles Martin, M.D., holds Oklahoma Medical License No. 10534.

2. That the Board of Medical Examiners en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.

3. That the Final Order issued following hearing of this matter on January 13, 1984, is still in full force and effect.

4. Probation reports obtained by the investigative staff of the Oklahoma State Board of Medical Examiners do not show any violation thereof.

5. Defendant requested amendment of the terms of his probation to allow the Defendant to write prescriptions for controlled dangerous substances without any requirement for co-signing or countersigning by another physician.

CONCLUSION OF LAW

1. That under the terms of the Oklahoma Medical Practice Act the Board retains jurisdiction over the subject matter herein and may in its discretion revise certain terms of probation.


ORDER

IT IS THEREFORE ORDERED by the Board of Medical Examiners of Oklahoma as follows:


1. That paragraphs l.b. and l.c. of the terms of probation set forth to the Defendant in the Board's Final Order issued following hearing on January 13, 1984, be and is hereby amended to read as follows:

- b. Defendant may prescribe controlled dangerous substances for patients without any countersigning or co-signing by any other physician, but that Defendant must maintain true and correct copies of all prescriptions he writes for controlled dangerous substances and make such records available to any inspector for the Oklahoma State Board of Medical Examiners.
- c. That all other terms and conditions of probation as set forth in the previously cited Final Order are hereby readopted and republished as previously set out by the Board.
