# ORDER MODIFYING TERMS OF PROBATION

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision on May 16, 2013, at the Board office, 101 N.E. 51<sup>st</sup> Street, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board.

Stacy Lynn Scroggins, PA, Defendant, appeared in person, pro se, thereby waiving her right to legal counsel.

The Board *en banc* after hearing testimony, reviewing exhibits, and being fully apprised of the premises, entered the following Findings of Fact, Conclusions of Law, and Orders:

#### **Findings of Fact**

- 1. Defendant currently holds Oklahoma medical license no. PA 1066.
- 2. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.
- 3. On September 17, 2009, after due notice and hearing, the Board entered an Order Accepting Voluntary Submittal to Jurisdiction whereby Defendant was placed on **PROBATION** for a period of five (5) years.

- 4. The Defendant requests that the term of her probation as currently stated in Paragraph D of the Order Accepting Voluntary Submittal to Jurisdiction (which states Defendant will not prescribe, administer, dispense or possess any drugs in Schedules II through V) be modified to allow her to prescribe Schedules III through V medications in accordance with the Physician Assistant Act of Oklahoma.
- 5. The Defendant requests that the term of her probation as currently stated in Paragraph O of the Order Accepting Voluntary Submittal to Jurisdiction (which states Defendant shall limit her work hours to forty (40) per week, no on-call duties, and no weekends) be modified to allow her to work on weekends and more than forty (40) hours per week, if necessary
- 6. The Defendant requests that the term of her probation as currently stated in Paragraph P of the Order Accepting Voluntary Submittal to Jurisdiction (which states Defendant shall not reapply for her DEA and OBN permits without first requesting and obtaining permission to do so by the Board) be completely removed and no longer be a requirement of her probation.
- 5. The Defendant presented sufficient evidence to support her Motion to Modify Probation.

#### Conclusions of Law

- 1. The Board has jurisdiction to hear this matter pursuant to 59 O.S. [480 et seq.
- 2. Defendant has presented satisfactory evidence to justify the modification to her probation allowing the following:
  - a. Paragraph D of the Order Accepting Voluntary Submittal to Jurisdiction be modified to allow her to prescribe Schedules III through V medications in accordance with the Physician Assistant Act of Oklahoma;
  - b. Paragraph O of the Order Accepting Voluntary Submittal to Jurisdiction be modified to allow her to work on weekends and more than forty (40) hours per week, if necessary; and
  - c. Paragraph P of the Order Accepting Voluntary Submittal to Jurisdiction be completely removed and no longer be a requirement of her probation.

#### Order

IT IS THEREFORE ORDERED by the Board of Medical Licensure and Supervision as follows:

- 1. Defendant's probation shall continue indefinitely as set forth in the Order Accepting Voluntary Submittal to Jurisdiction filed herein on September 17, 2009.
- 2. Defendant's probation shall be modified as currently stated in the Order Accepting Voluntary Submittal to Jurisdiction filed herein on September 17, 2009, as follows:
  - a. Paragraph D of the Order Accepting Voluntary Submittal to Jurisdiction be modified to allow her to prescribe Schedules III through V medications in accordance with the Physician Assistant Act of Oklahoma;
  - b. Paragraph O of the Order Accepting Voluntary Submittal to Jurisdiction be modified to allow her to work on weekends and more than forty (40) hours per week, if necessary; and
  - c. Paragraph P of the Order Accepting Voluntary Submittal to Jurisdiction be completely removed and no longer be a requirement of her probation.
- 3. During the period of probation, failure to meet any of the terms of probation will constitute cause for the Board to initiate additional proceedings to suspend or revoke Defendant's license, after due notice and hearing.
  - 4. A copy of this written order shall be sent to Defendant as soon as it is processed.
  - 5. This Order shall be effective May 16, 2013.
