ORDER FOR SUMMARY SUSPENSION

NOW ON this 15th day of August, 1994, there comes on before the undersigned Secretary of the Oklahoma Board of Medical Licensure and Supervision the above styled and numbered administrative action on the agency's application for emergency suspension of the defendant's license to practice medicine and surgery in this state. Plaintiff appeared by and through counsel. Defendant appeared in person. And the Secretary, acting in his authority pursuant to statute and rules of the Board, heard testimony and reviewed exhibits entered into evidence by the parties.

FINDINGS OF FACT

- 1. Michael Ewart Serjeant, the defendant, is licensed to practice medicine and surgery in the State of Oklahoma;
- 2. Under the authority of that licensed, the defendant has engaged in a pattern of practice in which he uses the drug Ketamine (Ketalor) in the treatment of his patients;
- 3. The defendant further prescribes or otherwise revises

prescriptions for controlled and dangerous drugs to his patients despite that the defendant is not authorized to prescribe controlled and dangerous drugs in this state;

- 4. The defendant fails to provide a proper setting for the use of Ketamine by his patients;
- 5. The procedures and protocol of the defendant create a clear and continuing danger to the health, safety and welfare of citizens of the State of Oklahoma;
- 6. It is imperative to the protection of the health safety and welfare of citizens of the State of Oklahoma that the license to practice medicine and surgery in this state be suspended until this matter can be heard by the Board of Medical Licensure and Supervision.

CONCLUSIONS OF LAW

- 1. The Secretary of the Oklahoma Board of Medical Licensure and Supervision has jurisdiction in this matter by virtue of the provisions of the Oklahoma Medical Practice Act, 59 O.S.1991, §§ 481 et seq., as amended, 59 O.S. § 491.1, 75 O.S. § 314, and the rules of the Board, OAC 435:1-1-10;
- 2. By virtue of the provisions of the Oklahoma Medical Practice Act, the Secretary of the Board has the power and jurisdiction to order an emergency suspension of a license at such times as is imperatively required for the protection of the public health, safety and welfare.

ORDER

It is therefore ORDERED that the license to practice medicine and surgery of the defendant, Michael Ewart Serjeant, M.D., is

suspended as of 12:00 o'clock noon, August 16, 1994, to continue until this matter is heard by the Board at its next Board meeting September 9 and 10, 1994.
