ORDER REINSTATING LICENSE
UNDER TERMS AND CONDITIONS OF PROBATION

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision en banc on the 11th day of February, 1988, at the meeting held at Comanche County Memorial Hospital, 3401 N. Gore Blvd., Lawton, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff, and Juan Lases, M.D., Defendant, did not appear in person but appeared by and through written request to the Secretary of the Board of Medical Licensure and Supervision.

The Board of Medical Licensure and Supervision en banc heard the testimony and reviewed exhibits and being fully advised in the premises, the Board of Medical Licensure and Supervision therefore finds as follows:

FINDINGS OF FACT

1. That Defendant, Juan Lases, M.D., holds Oklahoma Medical License No. 10828.
2. That the Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
3. That Defendant produced evidence he was still employed through part-time work at a service station, convenience store, and manufacturing plant for minimum wage, and that the Defendant was actively seeking employment in the medical field and had been looking outside the area of Tulsa, Oklahoma, but had found that he could not be hired for any medical position as long as his license was under suspension from this Board.
4. That the Defendant had remarried and was nearly bankrupt and was actively seeking employment in the medical field and had fulfilled all terms and conditions of suspension previously imposed by the Board.
5. That the Board had previously heard testimony from Dr. Robert Block who advised that he had been consulting with the Defendant, and Dr. Block had previously stated his opinion on the record that public health, safety and welfare could be protected and the Defendant could be improved and his recovery enhanced by return to medical practice under certain, limited terms and conditions.
6. That terms and conditions of probation could be fashioned by the Board to allow the Defendant some professional

improvement and practice and that would also protect public health, safety and welfare.

CONCLUSIONS OF LAW

1. That Juan Lases, M.D., holding Oklahoma Medical License No. 10828, remains under the continuing jurisdiction of the Oklahoma Board of Medical Licensure and Supervision and the Board has power upon receipt of sufficient evidence to terminate previously imposed suspension and to impose terms of probation on the Defendant's license.

ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

1. That the suspension of the Defendant's Oklahoma Medical License No. 10828 which began following hearing on September 5, 1986, should be and the same is hereby terminated, set aside and held for naught.

2. That the Defendant's Medical License is reinstated under probation to the Oklahoma State Board of Medical Licensure and Supervision for a period of five (5) years beginning February 11, 1988, under the following terms and conditions:

(a) Defendant may practice medicine and surgery exclusively and solely in a supervised setting with supervision by professional colleagues and appropriate lay personnel, such as hospital administrators and clinic managers.

(b) That when Dr. Lases secures employment as a physician and surgeon he shall appear before the Secretary of the Oklahoma Board of Medical Licensure and Supervision in order to discuss the circumstances thereof and that Dr. Lases shall obtain the authorization of the Board Secretary or his designee to commence any position of employment.

(c) That the Defendant shall be placed on Level I probation to be maintained by Investigators of the Oklahoma State Board of Medical Licensure and Supervision, excluding any need of bodily fluids from the Defendant, and that said Defendant shall remain on Level I probation for at least one (1) year from the date February 11, 1988.

(d) That the Defendant shall continue in support groups such as the sexual addiction group he presently attends and shall report on a monthly basis his attendance of those support groups to a representative of the Board of Medical Licensure and Supervision.

(e) That the Defendant will continue individual psychiatric and psychological therapy and authorize his physicians to report his progress and prognosis to the Oklahoma Board of Medical Licensure and Supervision.

(f) That the Defendant shall appear before the Board en banc whenever requested by the Board, and at least twice a year.

(g) That during the period probation Dr. Lases will furnish to the office of the State

Board of Medical Licensure and Supervision
all current legal addresses and any change of
address in writing.

(h) That during the period of probation
Defendant will submit to the Investigation
Division of the Oklahoma State Board of
Medical Licensure and Supervision any
required reports and forms on a timely and
prompt basis.

(i) Pursuant to Section 26, H.B. 1478, 1987
Legislature, Defendant shall promptly pay
upon receipt of invoice from the
Investigation Division of the Board the costs
of probationary supervision expended in this
case.

(j) That violation of any of the terms and
conditions of probation shall be grounds for
additional charges to be presented to the
Board after notice to the Defendant.

3. That the jurisdiction of the Board in this individual
proceeding will continue until the terms and conditions of
probation are modified or lifted by the Oklahoma Board of Medical
Licensure and Supervision on their own motion or on the motion of
the Defendant.


4. The Defendant further agrees that failure to meet any
of the above terms of probation will constitute cause for the
Board to initiate additional proceedings to suspend or revoke his
Oklahoma Medical License, after due notice and hearing.
