ORDER REINSTATING MEDICAL LICENSE UNTIL NEXT MEETING OF BOARD EN BANC

This cause came on for hearing before the Secretary of the Oklahoma Board of Medical Examiners en banc on March 30, 1987, at 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff, and the Defendant appeared in person, without counsel, and announced that he was ready to proceed without the assistance of counsel.

The Secretary heard testimony and reviewed exhibits and being fully advised in the premises, the Secretary therefore finds as follows:

FINDINGS OF FACT

- 1. That William Patrick Mappes, M.D., formerly held Oklahoma Medical License No. 10934 and that he desires reinstatement of same.
- 2. That on January 16, 1987, pursuant to notice and hearing, the Defendant appeared before the Board and the Board found that Defendant's urine sample presented to Inspector John Talbert on or around December 11, 1986, was analyzed and found to be positive for salicylates, acetominophen, opiates, benzodiozepines, and barbiturates (not phenobarb), and the Board further found that the presence of said substances in the Defendant's urine indicates that he ingested same and that such substances would adversely affect his ability to practice medicine or surgery as interpreted by the Oklahoma State Board of Medical Examiners, and further that the Defendant habitually used codeine and codeine products, a controlled dangerous substance, because of an aversion to pain, which according to Dr. Mappes is the result of the following documented conditions: Osteophyte C-6 and C-7, Wedging Vertibral Bodies T-7 and T-8, Compression Fractures T-11 and T-12, Post-Fracture Dorsal Spinus Process L-5, Spina Bifida Occulta S-1, Chronic Pateller Affusion-Right Knee, and chronic post-operative inflammation of left elbow.
- 3. That thereafter the Defendant did submit to a complete physical examination and psychological examination and the results of those examinations were reviewed by the Board Secretary and remain on file with the Board.
- 4. That the Defendant desires to resume the practice of psychiatry in association with Dr. Hal Chandler, M.D.
- 5. That Dr. Chandler is aware of these proceedings and by affixing his signature to this document agrees to strictly supervise the professional conduct and actions of the Defendant and to report to the Board immediately any significant deviation from the highest professional standards.

6. That the Defendant was placed on probation to the Oklahoma State Board of Medical Examiners for a period of five (5) years beginning on October 1, 1985, under certain terms and conditions and upon the reinstatement of his license said terms of probation will again be in full force and effect.

CONCLUSIONS OF LAW

- 1. That William Patrick Mappes, M.D., is lawfully under the jurisdiction of the Board of Medical Examiners for a term of five (5) years beginning on October 1, 1985.
- 2. That upon reinstatement of the Defendant's medical license the conditions and terms of probation which became effective on October 1, 1985, are reinstated and the Defendant must comply strictly therewith.
- 3. That following hearing before the Oklahoma Board of Medical Examiners on January 16, 1987, the Board specifically authorized the suspension of Defendant's license to run until the Defendant met with the Board Secretary and the Board Secretary investigated Defendant's present physical and mental condition and the exact facts and circumstances of his contemplated place of employment and until the Board Secretary circularized his recommendations to the members of the State Board of Medical Examiners and received a unanimous favorable response.

ORDER

- IT IS THEREFORE ORDERED by the Board of Medical Examiners of Oklahoma as follows:
- 1. That the medical license of Defendant William Patrick Mappes, M.D., Medical License No. 10934, should be and is hereby reinstated under the following terms and conditions:
 - (a) That said license is reinstated only to allow the Defendant to practice psychiatry in association with Dr. Hal Chandler, M.D., and only for so long a time as Dr. Hal Chandler agrees to supervise the professional activities of the Defendant.
 - (b) That in addition, all terms and conditions of probation which began on October 1, 1985, shall be in full force and effect and Defendant must strictly comply therewith.
- 2. That such reinstatement of Defendant's medical license is effective only until the next meeting of the Oklahoma Board of Medical Examiners en banc wherein the Defendant must appear at 3:00 k.m. on the 30% day of April , 1987, in order that the Board can make additional disposition on this matter.
- 3. Issuance of this Order by the Board Secretary, upon unanimous favorable response from the members of the State Board of Medical Examiners upon circulation, does not limit or bind the Board of Medical Examiners on any decision to be made at their next meeting of the Board en banc.

4. That Dr. Chandler must review this instrument and approve it before it will be considered by the Board Secretary.
