- 2. That the Oklahoma Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
- 3. That before hearing any testimony or reviewing any exhibits, the Board reviewed the Motion for Voluntary Surrender of License and the attached Affidavit prepared on behalf of the Defendant by Defendant's legal counsel. The Board found that the Motion for Voluntary Surrender of License constituted an appropriate disposition of this case and accepted same.
