ORDER ACCEPTING SURRENDER
OF DEFENDANT'S OKLAHOMA MEDICAL LICENSE

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on October 1, 1993, at the office of the Oklahoma State Board of Medical Licensure and Supervision, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff; and Virgilio T. Guzman, M.D., Defendant, appeared by way of Motion for Voluntary Surrender of License filed by legal counsel Edward F. Bruno, of Bruno & Weiner, 155 N. Michigan Ave., 6th Floor, Chicago, IL 60601.

That the Oklahoma Board of Medical Licensure and Supervision en banc heard oral statements of counsel, reviewed exhibits and being fully advised in the premises, the Oklahoma Board finds and orders as follows:

FINDINGS OF FACT

1. That Defendant, Virgilio T. Guzman, M.D., holds Oklahoma Medical License No. 10982.
2. That the Oklahoma Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
3. That before hearing any testimony or reviewing any exhibits, the Board reviewed the Motion for Voluntary Surrender of License and the attached Affidavit prepared on behalf of the Defendant by Defendant's legal counsel. The Board found that the Motion for Voluntary Surrender of License constituted an appropriate disposition of this case and accepted same.

CONCLUSIONS OF LAW

1. That the Oklahoma Board of Medical Licensure and Supervision has jurisdiction of this matter pursuant to the legal authority of the Oklahoma Medical Practice Act, 59 O.S. 1991, Sec. 481 et seq.

ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

1. That Defendant, Virgilio T. Guzman, M.D., holding Oklahoma Medical License No. 10982, submitted Motion for Voluntary Surrender of License and that said motion should be and the same is hereby ACCEPTED.

2. That a copy of this written Order should be sent to the Defendant and/or his legal counsel as soon as possible so his record is complete.
