**ORDER ACCEPTING VOLUNTARY SUBMITTAL TO JURISDICTION  
WITH MODIFICATIONS TO EXHIBIT A – TERMS OF PROBATION**

An Order Accepting Voluntary Submittal to Jurisdiction, with an Exhibit A – Terms of Probation (herein “Agreement” or “Order”), came before the Board on the 16th day of December, 2015.

At the hearing, the Board *en banc* adopted the Agreement of the Parties with certain modifications to the Exhibit A – Terms of Probation.

The Order was executed by the Board President, the Board Secretary, Plaintiffs’ Counsel AAG Jason T. Seay, Defendant Maria M. Kane and Defendant’s Counsel Danny K. Shadid. The Exhibit A – Terms of Probation was executed by the Board Secretary, Plaintiff’s Counsel AAG Seay, Defendant Maria M. Kane and Defendant’s Counsel Danny K. Shadid.

Specific Term of Probation Paragraph 10, of Exhibit A, states:

10. The Defendant shall obtain a practice monitor and mentor approved of by the Board Secretary. The practice monitor shall have not been used or named as an expert in the above-captioned proceeding, or was consulted regarding the above-captioned proceeding. The mentor shall review patients’ records, observe the Defendant’s interaction with patients and provide advice, where necessary, for improvement of the Defendant’s psychiatric practice. Such includes, but is not limited to, treatment, diagnoses, patient management, practice management, and any other aspect of patient care. The practice monitor and mentor shall agree to make himself or herself available to Board staff and will cooperate with Board staff in their monitoring of the Defendant and her practice, including providing quarterly reports to the Board Secretary. If the parties are unable to agree to a practice monitor/mentor within thirty (30) days from the date of the Order to


which this Exhibit is attached, then either may make application with the Board for the approval of a mentor for the purposes stated herein.

In accordance with the Board's requirement for modification to the Exhibit A, Paragraph 10 is hereby modified as follows (changes in bold and underlined):

10. The Defendant shall obtain a practice monitor and mentor **who is board certified in psychiatry and participates in maintenance of certification. The practice monitor and mentor shall be** approved of by the Board Secretary. The practice monitor shall have not been used or named as an expert in the above-captioned proceeding, or was consulted regarding the above-captioned proceeding. The mentor shall review patients' records, observe the Defendant's interaction with patients and provide advice, where necessary, for improvement of the Defendant's psychiatric practice. Such includes, but is not limited to, treatment, diagnoses, patient management, practice management, and any other aspect of patient care. The practice monitor and mentor shall agree to make himself or herself available to Board staff and will cooperate with Board staff in their monitoring of the Defendant and her practice, including providing quarterly reports to the Board Secretary. If the parties are unable to agree to a practice monitor/mentor within thirty (30) days from the date of the Order to which this Exhibit is attached, then either may make application with the Board for the approval of a mentor for the purposes stated herein. **The Defendant shall be responsible for any costs of monitoring.**

**IT IS THEREFORE ORDERED** that the Exhibit A - Terms of Probation, Paragraph 10, under the Specific Terms section, is hereby modified with the additional text as shown above.
