ATTORNEY GENERAL OPINION 2017-202A

Dear Secretary Stout:

This office has received your request for a written Attorney General Opinion regarding agency action that the State Board of Medical Licensure and Supervision intends to take pursuant to a Voluntary Submittal of Jurisdiction with respect to Medical Doctor Licensee 11134. The proposed action is to enforce the terms of the consent agreement by extending probation until such time as the licensee completes, and obtains satisfactory verification of completion of, the required continuing medical education ("CME") courses. In 2016, the licensee entered into a voluntary submittal of jurisdiction setting probation terms which included imposing a \$9,000 fine and attending two CME courses, one in proper charting for psychiatrists and one for psychiatric care of patients who are also undergoing pain management care, to be completed within nine months. The terms of probation also required the licensee to inform employers as well as other states' licensing boards of the discipline; notify the Board of any change in address; personally appear before the Board as requested; execute releases of medical and psychiatric records as necessary; seek prior approval from the Board for any change in employment; obtain an approved practice monitor and mentor; file practice reports; and make payments to the Board. The licensee failed to submit certificates of completion for the two required CME courses in violation of the order.

The Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act, 59 O.S.2011 & Supp.2016, §§ 480–518.1, authorizes the Board to discipline licensees for willful violations of its orders. 59 O.S.2011, § 513(B). Further, the Board is authorized to take appropriate disciplinary actions which may include "[s]atisfactory completion of education...programs." 59 O.S. 2011, §§ 506(A), 509.1(A)(8); OAC 435:5-1-3. The action enforces the requirement that licensees comply with the Board's orders. The Board may reasonably believe that extending probation and requiring the licensee to produce evidence of completion of continuing education is necessary to deter future violations.

It is, therefore, the official opinion of the Attorney General that the State Board of Medical Licensure and Supervision has adequate support for the conclusion that this action advances the State of Oklahoma's policy upholding minimum standards of professionalism among physicians.
