**ORDER TERMINATING TERMS OF AGREEMENT**

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision ("Board") on November 18, 2021, at the office of the Board, 101 N.E. 51<sup>st</sup> Street, Oklahoma City, Oklahoma 73105, pursuant to notice given as required by law and the rules of the Board.

Gary Ricks, Compliance Coordinator for the Board, appeared on behalf of Plaintiff. Zane Matthew Bendall, P.T.A. appeared in person, *pro se*. Plaintiff and Defendant are collectively referred to herein as the "Parties."

The following witnesses were sworn and testified: Zane Matthew Bendall, P.T.A. and Gary Ricks, Compliance Coordinator.

The Board, having heard testimony, considered representations of the witnesses and being fully apprised of the premises, makes the following findings of fact, conclusions of law and orders, by clear and convincing evidence:

**Findings of Fact**

1. In Oklahoma, Defendant holds Physical Therapy Assistant license no. 1116, originally issued November 19, 2001.
2. On November 7, 2019, an Order Granting Reinstatement of License After Suspension Under Terms of Agreement ("2019 Order") was entered and filed herein on November 11, 2019.
3. On October 13, 2021, Staff's Motion to Terminate Agreement Portion of the 2019 Order was filed herein.
4. Mr. Ricks, Compliance Coordinator, testified that Mr. Bendall has complied with all the terms of the agreement portion as set forth in the 2019 Order. Mr Ricks further testified that based on his good compliance, Board staff moves to terminate the agreement portion of the 2019 Order.
5. Any finding of fact which is more properly characterized as a conclusion of law is hereby incorporated as a conclusion of law.

**Conclusions of Law**


- 6. The Board has jurisdiction over the subject matter and is a duly authorized agency of the State of Oklahoma empowered to license and oversee the activities of physical therapists and physical therapist assistants in the State of Oklahoma. 59 O.S. § 887.1 *et seq.* and Okla. Admin. Code § 435:20-1-1 *et seq.*
- 7. Notice was provided as required by law and the rules of the Board. 75 O.S. § 309; 59 O.S. § 504; Okla. Admin. Code §§ 435:3-3-5, 435:3-3-6.
- 8. Any conclusion of law which is more properly characterized as a finding of fact is hereby incorporated as a finding of fact.

**Orders**

**IT IS THEREFORE ORDERED** by the Oklahoma State Board of Medical Licensure and Supervision as follows:

- 9. The Agreement portion contained in the Order Granting Reinstatement of License After Suspension Under Terms of Agreement filed herein on November 11, 2019 is terminated.
- 10. A copy of this Order shall be provided to Defendant as soon as it is processed.
