AGREED ORDER OF REPRIMAND WITH STIPULATIONS

This cause came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision on January 9 and 10, 1997, at the offices of the Oklahoma State Board of Medical Licensure and Supervision, 5104 North Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Gregory J. Ryan, Attorney at Law, appeared for the plaintiff; Stanley Scott Hanan, M.D., defendant, appeared by counsel, Mark Hammons, Attorney at Law.

The parties jointly submit this Agreed Order for the Board en banc's review and adoption.

The Oklahoma State Board of Medical Licensure and Supervision, being fully advised in the premises, finds and orders as follows:

- 1. That the defendant, Stanley Scott Hanan, M.D., holds Oklahoma Medical License Number 11542.
- 2. That the Oklahoma State Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
- 3. That the defendant has prescribed significant amounts of controlled

dangerous substances to patients "J.C.," "C.B.," "J.T.," "J.O.," "J.F.," "L.A.," "S.L.," and "E.A.."

- 4. That the defendant has failed to comply with requests from the staff of the Oklahoma State Board of Medical Licensure and Supervision to provide patient records and logs for acquiring and dispensing controlled and dangerous drugs, however, the Board notes that defendant explains this failure as being based on the actions of a financial institution which allegedly took possession of the office, refused to return patient files, and destroyed records without defendant's consent.
- 5. The defendant's actions caused a significant harm to the public health, safety and welfare and, if uncorrected, could have the potential to cause such harm again.

CONCLUSIONS OF LAW

- 1. That the Defendant, Stanley Scott Hanan, M.D., holding Oklahoma Medical License Number 11542, is in violation of the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Action, 59 O.S. 1994, §509, Paragraphs 11, 13 and 17, to-wit:
 - Failure to keep complete and accurate records of purchase and disposal of controlled drugs or of narcotics drugs;

- 13. Prescribing or administering a drug or treatment without sufficient examination and the establishment of a valid physician/patient relationship;
- 17. Prescribing, dispensing or administering of controlled substances or narcotic drugs in excess of the amount considered good medical practice, or prescribing, dispensing or administering controlled substances or narcotic drugs without medical need in accordance with published standards.

The violation of 59 O.S. §509 (13) is based upon the failure to properly document in defendant's records the examination of the patients and the basis for the need for the prescriptions.

2. The defendant is also in violation of the Oklahoma Administrative Code (Rules and Regulations of the Oklahoma State Board of Medical

Licensure and Supervision) 435:10-7-4, paragraphs 1,2 and 36, to-wit:

- 1. Indiscriminate or excessive prescribing, dispensing or administering of controlled or narcotic drugs.
- Prescribing, dispensing or administering of controlled substances or narcotic drugs in excess of the amount considered good medical practice, or prescribing, dispensing or administering controlled substances or narcotic drugs without medical need in accordance with published standard.
- 36. Improper management of medical records.

ORDER AND STIPULATIONS

IT IS THEREFORE ORDERED by the Oklahoma State Board of Medical Licensure and Supervision as follows:

- The Defendant, Stanley Scott Hanan, M.D., Oklahoma Medical License Number 11542, should be and the same is hereby officially reprimanded.
- 2. The parties have stipulated that the defendant has decided not to renew his Oklahoma medical license and that if the defendant ever attempts to renew his Oklahoma medical license, he will be subject to probation and monitoring commencing upon the date that his Oklahoma medical license is renewed, if ever.
- 3. The parties have also stipulated that the defendant will not contract with any nursing home or other health care facility in Oklahoma and that he will not practice medicine in the State of Oklahoma without first renewing his Oklahoma license and complying with the provisions of paragraph 2 above.
- 4. The Oklahoma State Board of Medical Licensure and Supervision hereby accepts and adopts the parties' stipulations.

IT IS SO ORDERED.
