ORDER TERMINATING PROBATION

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision en banc on the 11th day of May, 1989, at the office of the Oklahoma Board of Medical Licensure and Supervision, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff; and Jack Mattingly, Attorney, Seminole, Oklahoma, appeared by announcement of Plaintiff's counsel.

The Board of Medical Licensure and Supervision en banc heard testimony and reviewed exhibits and being fully advised in the premises, the Board of Medical Licensure and Supervision therefore finds as follows:

FINDINGS OF FACT

1. That Defendant, John Brendon O'Keeffe, M.D., holds Oklahoma Medical License No. 11660.
2. That the Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
3. That following notice and hearing on May 13, 1988, the Defendant was placed on probation to the Oklahoma State Board of Medical Licensure and Supervision for a period of three (3) years, beginning on May 13, 1988, under certain enumerated terms and conditions.
4. That since the imposition of that probation, the Defendant has been routinely reviewed by the Investigation Division of the Oklahoma State Board of Medical Licensure and Supervision and found to be in general compliance with the terms and conditions ordered by the Board.
5. That at the time of its meeting on February 3, 1989, the Board voted to hold in abeyance the Defendant's Motion to Terminate Probation filed on or around December 2, 1988, and to defer any decision until the meeting of April, 1989.
6. That in the time from the meeting of February 3, 1989, to date, the Investigation Division of the Oklahoma State Board of Medical Licensure and Supervision did not discover any evidence that is negative toward an early termination of probation.

7. That active probation in this case is no longer necessary to protect public health, safety or welfare.

CONCLUSIONS OF LAW

1. Under the Oklahoma Medical Practice Act, 59 O.S. Supp. 1988, Sec. 481 et seq., the Board has continuing jurisdiction over the terms and conditions of probation and may modify or terminate same as the evidence permits.


ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:


