**ORDER DENYING LICENSURE**

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision on May 20, 2004, at the office of the Board, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board.

Applicant appeared, *pro se*, before the Board, thereby waiving his right to legal counsel.

The Board *en banc* heard testimony, reviewed the application and all attached exhibits, and being fully apprised of the premises, made the following Findings of Fact, Conclusions of Law and Orders:

***FINDINGS OF FACT***

Applicant applied for licensure in Oklahoma as a physician and surgeon.

2. The Board *en banc* has jurisdiction over the subject matter herein and notice has been given in all respects as required by law and the rules of the Board.

3 The evidence reflects that:

- a. Applicant's request to reactivate his Colorado medical license was denied on or about February 19, 2002.
- b. Applicant has a significant history of malpractice lawsuits and judgments against him.

4. These factors raise serious issues as to the Applicant's ability to practice medicine and surgery with reasonable skill and safety, and the Applicant has failed to produce evidence to

overcome these issues as to his competency and fitness to practice under a full medical license in the State of Oklahoma.

**CONCLUSIONS OF LAW**


- 1 The Board has jurisdiction to hear this matter pursuant to 59 O. S. § 481 *et seq.*
- 2. Applicant failed to fulfill the requirements of 59 Okla. Stat. §481 *et seq.*, and the applicable rules of the Board, to qualify for a full medical license in Oklahoma as a physician and surgeon.

**ORDER**

**IT IS THEREFORE ORDERED** by the Board of Medical Licensure and Supervision as follows


- 1. Application Number 11701 filed by Otmar Wolf Albrand for a full medical license in Oklahoma is **DENIED**.
