

## LIMITED MODIFICATION TO VOLUNTARY SUBMISSION TO JURISDICTION AND STIPULATION

This Limited Modification to Voluntary Submission to Jurisdiction and Stipulation is entered into this 22 day of October, 1996, by and between the Oklahoma State Board of Medical Licensure and Supervision (the "Board") and Alice E. McInnis, M.D. ("McInnis").

## WITNESSETH:

WHEREAS, McInnis is the holder of Medical License No. 11880;

WHEREAS, on or about May 30, 1996, the Board and McInnis entered into a Voluntary Submission to Jurisdiction and Stipulation (the "VSJ") in connection with the complaint previously filed against McInnis with the Board in an action styled, to-wit: State of Oklahoma, ex rel. State Board of Medical Licensure and Supervision v. Alice E. McInnis, Medical License No. 11880, Case No. 96-01-1790;

WHEREAS, under the terms of the VSJ, McInnis agreed to refrain completely from any and all practice of medicine, either within the State of Oklahoma, or within any other jurisdiction or locale, until she reappeared before the Board *en banc* at its meeting at the end of July, 1996;

WHEREAS, a Joint Motion for Continuance of Hearing and Adoption/Extension of the VSJ (the "Joint Motion") was subsequently filed with the Board, and the Board subsequently entered an Order (the "Order") continuing the hearing and adopting and extending the terms and conditions of the VSJ until McInnis reappeared before the Board *en banc* at the regularly scheduled hearing in the early part of 1997;

WHEREAS, on September 20, 1996, McInnis filed an Application for Limited Modification to Voluntary Submission to Jurisdiction and Stipulation (the "Application") seeking

an order from the Board modifying the VSJ for the limited and specific purpose of allowing Dr. McInnis to: (1) travel with a missionary group to Mexico to perform limited physical examinations for impoverished individuals; and (2) accept a part-time position at the Medical Entrance Processing Station of the Armed Forces Induction Center in Oklahoma City, Oklahoma ("MEPS") for the purpose of performing limited physical examinations;

WHEREAS, the Application came on for hearing before the Board *en banc* on September 26, 1996, and the Board, after considering the Application and the arguments of counsel with respect thereto, unanimously voted to grant the Application.

NOW, THEREFORE, the Secretary of the Board, the Board, and McInnis stipulate and agree as follows:

1. Limited Modification to Paragraph 6 of VSJ. The Board and McInnis agree that as of the date of the hearing on the Application, September 26, 1996, the agreement of McInnis to temporarily refrain from the practice of medicine as set forth in paragraph 6 of the VSJ shall be modified in order to allow McInnis to: (1) travel with a missionary group to Mexico in October of 1996, to perform limited physical examinations for impoverished individuals; and (2) accept a part-time position at the MEPS for the purpose of performing limited physical examinations. Other than the limited modification to paragraph 6 of the VSJ as set forth herein, McInnis agrees to continue to refrain from any other practice of medicine, either within the State of Oklahoma or with any other jurisdiction or locale, until she reappears before the Board *en banc* at the regularly scheduled hearing in the early part of 1997.

2. <u>Continued Force and Effect of Modified VSJ</u>. The Board and McInnis agree that other than as set forth herein, the terms and conditions of the VSJ as modified by the Joint Motion and Order, shall remain in full force and effect.
