ORDER TERMINATING PROBATION

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision on March 4, 1999 at the office of the Board, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board. Defendant appeared in person before the Board.

The Board *en banc* heard testimony and being fully apprised of the premises, made the following Findings of Fact:

FINDINGS OF FACT

1. Defendant Alice E. McInnis, M.D. holds Oklahoma Medical License No. 11880.
2. The Board *en banc* has jurisdiction over the subject matter herein and notice has been given in all respects as required by law and the rules of the Board.
3. Defendant was placed on a five year probation on May 16, 1997 by the Board *en banc* after hearing testimony.
4. Defendant filed a motion on February 4, 1999 requesting termination of probation.
5. Defendant provided sufficient evidence that the terms of probation could be terminated without presenting harm to public safety and welfare.
6. Defendant's request for termination of probation should be granted.

CONCLUSIONS OF LAW

1. The Board has legal authority over the defendant and the subject matter herein pursuant to the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act, 59 O.S. ss. 480 et seq., and the Oklahoma Administrative Code, Title 435:1-1-1 et seq.


ORDER
