FINAL ORDER GRANTING REINSTATEMENT UNDER TERMS OF AGREEMENT

This matter came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on March 27, 1998, at the office of the Board, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board.

Larry L. Broadie (Applicant) appeared in person and with counsel, Douglas A. Rice and Larry Derryberry. Susan Moebius Henderson, Assistant Attorney General, appeared on behalf of the Oklahoma State Board of Medical Licensure and Supervision (Board).

The Board heard testimony, reviewed the materials and, being fully apprised of the premises, made the following Findings of Fact:

FINDINGS OF FACT

- 1. Applicant previously held Oklahoma Medical License No. 12218.
- 2. On January 9, 1997, the Board revoked Applicant's license for unprofessional conduct in violation of 59 Okla. Stat. \$509(9) and the Oklahoma Administrative Code 435:10-7-4 (8), (18), and (32).
 - 3. Applicant applied for reinstatement on February 9, 1998.
- 4. The Board has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.

CONCLUSIONS OF LAW

- 1. The Board has jurisdiction over the subject matter herein pursuant to Title 59 Okla. Stat. §480 et seq.
 - 2. Reinstatement is proper under 59 Okla. Stat. \$508.2 and OAC 435:10-4-11.

ORDER

IT IS THEREFORE ORDERED by the Board of Medical Licensure and Supervision that Applicant's Oklahoma Medical License No. 12218 be reinstated to authorize Applicant to practice in Oklahoma as a physician and surgeon under the following terms of agreement established between the Board Secretary and Applicant pursuant to Oklahoma Administrative Code 435:10-4-11:

- a. A retrospective, random chart review of Applicant's patients will be conducted periodically by a physician chosen by the Board.
- b. Applicant will obtain the agreement of the Chief of Medical Staff of the Mangum City Hospital and any other hospital in which Applicant obtains privileges to submit a monthly report to the Board stating that there have been no complaints from any source and no adverse actions taken or considered by the hospital staff or administration with respect to Applicant's practice.
- c. Any charges or other expenses generated by these requirements will be paid by the Applicant immediately upon his receipt of an invoice from the Board.
- d. The terms of the agreement shall be of a continuing nature until set aside or otherwise terminated by the Board.
- e. Failure to comply with the terms of the agreements shall be considered a violation of the rules of the Board and shall be grounds for disciplinary action by the Board, up to and including revocation, pursuant to, among other things, OAC 435:10-7-4 (11) and (39).
