ORDER OF REPRIMAND

THIS CAUSE came on for hearing before the Oklahoma State Board of Medical  
Licensure and Supervision, ( hereinafter "OSBMLS" ), en banc on the 15th day of May,  
1997 at the offices of OSBMLS, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma,  
pursuant to notice given as required by law and the rules of the Board.

The plaintiff appears by and through its attorney, Danny K. Shadid; the  
defendant appears in person and by his attorney, Nathan J. Gigger.

The Board heard testimony and received exhibits during the first portion of the  
hearing on March 13th, 1997. At the continuation of the hearing on May 15th, 1997,  
the Board received the Summary of Evaluation of Wazir S. Ahmad by Gene G. Abel,  
M.D. as additional evidence. After having received such evidence, hearing the  
arguments of counsel and being fully advised in the premises, the Board finds that  
there is clear and convincing evidence of the following findings of fact and conclusions  
of law;

## FINDINGS OF FACT

1. That the defendant Wazir S. Ahmad, M.D. holds Oklahoma Medical License No. 12461.
2. That the OSBMLS has jurisdiction over the defendant and the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
3. Regarding Count I of the Complaint, there is clear and convincing evidence to support the existence of the following facts:
  - a. Defendant has practiced as a pediatrician in Oklahoma City, Oklahoma since 1981. Defendant received as patients the children of Charles and Yvette Dixon from or about November, 1989, through the present time. The defendant received as patients the children of Michael and Carlotta Parham in 1990 and 1991. The defendant received as patient the child of Joseph and Yolonda McCormick from or about November, 1993 through or about December, 1996.
  - b. While treating their children as patients, the defendant dated and entered into sexual relationships with Yvette Dixon, Carlotta Parham, and Yolonda McCormick.
  - c. A September 9, 1993 ruling in the District Court of Oklahoma County, Case No. FD-91-8360 declared the defendant to be the father of a child born to Carlotta Parham on December 14, 1991.
  - d. The defendant's pattern in engaging in sexual relationships with the mothers of his pediatric patients constitutes unprofessional conduct. As to Carlotta Parham, Yvette Dixon and their respective children, the defendant's conduct is in violation of 59 O.S. Supp. 1996, Section 509 (9). As to Yolonda McCormick

and her child, the defendant's conduct is in violation of 59 O.S. Supp. 1996, Section 509 (9) and O.A.C. Title 435: 10-7-4 (11) and (23).

4. Regarding Count II of the Complaint, there exists clear and convincing evidence to support the fact that on June 13, 1996, the OSBMLS served the defendant with a subpoena for medical records in the course of its investigation and the defendant failed to cooperate with this investigation or to provide records lawfully subpoenaed, all in violation of 59 O.S. Supp. 1996, Section 509 (9), together with O.A.C. Title 435: 10-7-4 (37) and (38).

5. That as a result of the evidence brought forth by the complaint, the Board finds that the defendant perpetuated significant harm to the public health, safety and welfare by committing the acts and/or omissions set forth in the allegations in the complaint.

#### CONCLUSIONS OF LAW

6. The Defendant Wazir S. Ahmad, M.D., holding Oklahoma Medical License No. 12461, is in violation of the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act, 59 O.S. Supp. 1996, Section 509 (9) and the O.A.C., Title 435: 10-7-4 (11), (23), (37) and (38).

7. The Board holds by clear and convincing evidence that the defendant has been guilty of unprofessional conduct in violation of the statutory and administrative code provisions set forth above.

8. The Board has authority vested in it through 59 O.S. Section 509.1 to impose disciplinary action.


9. The Board holds that the defendant should be subject to a reprimand censuring the activity described above.

ORDER


IT IS THEREFORE ORDERED by the Oklahoma State Board of Medical
