ORDER AMENDING TERMS OF PROBATION

The Defendant appeared before the Oklahoma Board of Medical Examiners en banc on September 27, 1985, at 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

The Board of Medical Examiners en banc reviewed the exhibits and being fully advised in the premises the Board of Medical Examiners therefore finds as follows:

FINDINGS OF FACT

1. That on or around May 15, 1982, following notice and hearing, the Oklahoma Board of Medical Examiners ordered that Defendant be placed on five years probation under certain terms and conditions.

2. That on or around May 21, 1983, Defendant voluntarily appeared before the Board and the Board amended the terms of probation to allow the Defendant to write prescriptions for controlled substances of Schedule II, III, IV and V in a hospital only, and not in any other setting, and that the Defendant be permitted to re-apply upon his own initiative to the Drug Enforcement Authority and the Bureau of Narcotics and Dangerous Drugs.

3. That the Defendant now requests to receive permission to administer, prescribe and dispense scheduled drugs in nursing homes as well as hospitals.

4. That during the term of his probation to date, the Board has no evidence of any violation of any terms and conditions of probation.

CONCLUSIONS OF LAW

1. That the Defendant is still under the continuing jurisdiction of the Oklahoma Board of Medical Examiners pursuant to its statutory authority, 59 O.S. 1981, §481, et seq.

ORDER

IT IS THEREFORE ORDERED by the Board of Medical Examiners of the State of Oklahoma as follows:


1. That the terms of probation originally imposed on the Defendant by Order of May 15, 1982, and May 21, 1983, remain in full force and effect except that Defendant shall be allowed to write prescriptions for controlled substances of Schedule II, III, IV and V in a hospital and in nursing homes, and not in any other settings, and that the Defendant shall be permitted to re-apply upon his own initiative to the Drug Enforcement Authority and the Bureau of Narcotics and Dangerous Drugs.

2. That all other terms and conditions of probation imposed on the Defendant by Order of May 15, 1982, remain in full force and effect.
