ORDER EXTENDING TERMS OF PROBATION

This cause comes on for hearing before the Oklahoma Board of Medical Examiners en banc on September 5, 1986, at 5104 North Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff, and the Defendant, Michael Louis Rosenfeld, M.D., appeared in person without counsel and agreed to proceed, waiving his right to representation by legal counsel.

The Board of Medical Examiners en banc heard the testimony and reviewed the exhibits, and being fully advised in the premises, the Board of Medical Examiners therefore finds as follows:

FINDINGS OF FACT

1. That Michael Louis Rosenfeld, M.D., holds Oklahoma Medical License No. 12509.

2. That the Board of Medical Examiners en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.

3. That on or around May 15, 1982, following notice and hearing, the Oklahoma Board of Medical Examiners ordered that Defendant be placed on five years' probation under certain terms and conditions.

4. That on or around May 21, 1983 and again on or around September 27, 1985 the Defendant voluntarily appeared before the Board and requested amendments in the terms of probation. Those amendments were granted by the Board.

5. That the Defendant now requests an extension on the original five-year probation for an additional three years. Defendant understands he is under no obligation to make this request and, absent the Defendant's affirmative request, the probation will expire of its own terms on or around May 15, 1987.

6. That during the term of Defendant's probation to date, the Board has no evidence of any violation of any terms and conditions of probation.

CONCLUSION OF LAW

1. That the Defendant is still under the continuing jurisdiction of the Oklahoma Board of Medical Examiners pursuant to the aforesaid Orders of May 15, 1982 and May 21, 1983 and pursuant to its statutory authority, 59 O.S. 1981, §481, et seq. and pursuant to his affirmative request made voluntarily at his appearance on September 5, 1986.

ORDER

IT IS THEREFORE ORDERED BY THE Board of Medical Examiners of Oklahoma as follows:

1. That the terms of probation originally imposed on Defendant by Order of May 15, 1982 and May 21, 1983, as amended by the Board of Medical Examiners on September 27, 1985, remain in full force and effect.


2. That upon the affirmative request of the Defendant, the terms of probation that would otherwise expire on or around May 15, 1987, should be continued for three years past that date or until May 15, 1990.

3. That all other terms and conditions of probation imposed on Defendant by Orders of May 15, 1982, May 21, 1983 and September 27, 1985 remain in full force and effect.


