### ORDER TERMINATING PROBATION

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision en banc on the 11th day of May, 1989, at the office of the Oklahoma Board of Medical Licensure and Supervision, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff; and Michael Louis Rosenfeld, M.D., Defendant, appeared in person, pro se, and announced he was ready to proceed without the assistance of counsel.

The Board of Medical Licensure and Supervision en banc heard testimony and reviewed exhibits and being fully advised in the premises, the Board of Medical Licensure and Supervision therefore finds as follows:

## FINDINGS OF FACT

- 1. That Defendant, Michael Louis Rosenfeld, M.D., holds Oklahoma Medical License No. 12509.
- 2. That the Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
- 3. That on or around May 15, 1982, following notice and hearing, the Oklahoma Board of Medical Examiners ordered that Defendant be placed on five years probation under certain terms and conditions.
- 4. That on or around May 21, 1983, and again on or around September 27, 1985, the Defendant voluntarily appeared before the Board and requested amendments in the terms of probation. Those amendments were granted by the Board.
- 5. That on or around September 5, 1986, the Defendant requested an extension on the original five-year probation for an additional three years. Defendant understood he was under no obligation to make that request and, absent the Defendant's affirmative request, the probation will expire of its own terms on or around May 15, 1987.
- 6. That since the extension of probation requested by the Defendant and imposed by the Board at its meeting of September, 1986, the Defendant has been in compliance therewith and the Board has no evidence of any violation of any terms and conditions of probation.

7. That the Board feels that continuing to maintain probation on Dr. Rosenfeld will not aid or assist him anymore and is no longer necessary to protect public health, safety and welfare.

## CONCLUSIONS OF LAW

1. That by virtue of maintaining his licensure the Defendant is still under the continuing jurisdiction of the Oklahoma Board of Medical Licensure and Supervision, and the Board has discretion pursuant to its statutory authority, 59 O.S. 1981, Sec. 481 et seq., to terminate probation at any time.

## ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

- 1. That the terms of probation originally imposed on the Defendant by Order of May 15, 1982, and May 21, 1983, as amended by the Board of Medical Examiners on September 27, 1985, and re-imposed at the Defendant's request by Order following the meeting of September 5, 1986, should be and the same are hereby TERMINATED.
- 2. That a copy of this Order Terminating Probation should be placed in the Defendant's public licensure file and the Defendant should receive a copy thereof.
