# FINAL ORDER ON COMPLAINT OF CONTEMPT

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision en banc on the 15th day of September, 1988, at the office of the Oklahoma State Medical Association, 601 NW Expressway, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff; and Stan Twardy, Attorney, appeared for the Defendant.

The Board of Medical Licensure and Supervision en banc heard testimony and reviewed exhibits and being fully advised in the premises, the Board of Medical Licensure and Supervision therefore finds as follows:

### FINDINGS OF FACT

- 1. That Defendant, Tien-Sheng Tu, M.D., holds Oklahoma Medical License No. 12552.
- 2. That the Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
- 3. Defendant was lawfully served with a Complaint and Citation that alleged certain violations of the Oklahoma Medical Practice Act, 59 O.S. 1981, Sec. 509.
- 4. That following notice and hearing on November 3, 1984, the Board did cause to issue a Final Order which placed the Defendant on probation for a period of five years beginning on November 3, 1984. The terms and condition of probation included the following requirement, to-wit:
  - "b. During the period of probation Dr. Tu will furnish to the office of the State Board of Medical Examiners all current legal addresses and any change of address in writing . . ."
- 5. That the aforesaid Final Order imposed by the Board following notice and hearing on November 3, 1984, has remained in force and effect and has not been modified or changed in regard to the above requirement.
- 6. That on or around August 8, 1987, Defendant did report to Inspector Landreth that his residence was moved to 6612B NW 10th, Oklahoma City, Oklahoma, and later that his residence was moved to 402 Farmer Street, Norman, Oklahoma.

That since that date investigators of the State Board of Medical Licensure and Supervision have been unable to contact Dr. Tu in person or in writing at either of the above addresses and the Board has not been advised by the Defendant of any other legal address, either temporary or permanent in nature.

#### CONCLUSIONS OF LAW

1. That Defendant, Tien-Sheng Tu, M.D., holding Oklahoma Medical License No. 12552, remains under the jurisdiction of the Oklahoma Board of Medical Licensure and Supervision based on the probation imposed on November 3, 1984, and still in progress.

### ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

- That the probation imposed on the Defendant for a period of five (5) years, beginning on November 3, 1984, is tolled and held in abeyance effective September 10, 1987. The probation will be tolled until the Defendant returns to Oklahoma and notifies the Board of his current lawful address within the jurisdiction.
- That the staff is to communicate this decision to Defendant's counsel and to the Defendant at his last known best address.

Exceptions are herein granted to the Defendant.
