VOLUNTARY SURRENDER OF LICENSE IN LIEU OF PROSECUTION


I, Jamie Louise Shackelford, OT (“Defendant”), being of lawful age and after first being duly sworn, depose and state as follows:


1. I desire and hereby do voluntarily surrender my Oklahoma occupational therapy license no. 1269. 59 O.S. 509.1(E), *et seq.*
2. The surrender of my license is freely and voluntarily made. I have not been subject to any coercion or duress, and I am fully aware of the consequences of the surrender of my license.
3. I am the subject of an investigation and proceeding by the Oklahoma State Board of Medical Licensure and Supervision (“Board”) involving allegations which, if proven in a hearing on the matter, would constitute grounds for disciplinary action by the Board.
4. From October 31, 2021, through at least March 31, 2023, I was engaged in the practice of occupational therapy at my place of employment, Independent School District No. I-89 of Kingfisher County, OK (“Cashion Schools”) with an inactive, expired license.
5. During this time, I was aware that my license to practice occupational therapy was expired.

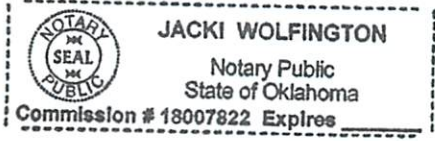
6. I am guilty of unprofessional conduct by violating the following rules of professional conduct:
- a. Practicing occupational therapy without being licensed in accordance with the provisions of the Occupational Therapy Practice Act, in violation of 59 O.S. § 888.4(A).
 - b. Failing to timely make application for license renewal, in violation of Okla. Admin. Code § 435:30-1-10(a)(21).
 - c. Violation of any provision(s) of the Occupational Therapy Practice Act or the rules and regulations of the board or of an action, stipulation, agreement or order of the Board, in violation of Okla. Admin. Code § 435:30-1-10(a)(28).
10. I understand that I am ineligible to apply for reinstatement of my Oklahoma occupational therapist license for a minimum of one (1) year from the date this surrender is accepted by the Board. Any reinstatement will be under terms and conditions as imposed by the Board.
11. If the Board does not accept this Voluntary Surrender of License in Lieu of Prosecution, the Plaintiff and Defendant (collectively, the "Parties") stipulate that it shall be regarded as null and void. Admissions by Defendant herein, if any, shall not be regarded as evidence against him in a subsequent disciplinary hearing. Defendant will be free to defend himself, and no inferences will be made from his willingness to have this Order accepted by the Board. The Parties stipulate that neither the presentation of the Order nor the Board's consideration of this Order shall be deemed to have unfairly or illegally prejudiced the Board or its individual members and, therefore, shall not be grounds for precluding the Board nor any individual Board member from further participation in proceedings related to the matters set forth herein.
