ORDER TERMINATING PROBATION

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on October 21, 1989, at the office of the Oklahoma State Medical Association, 601 N.W. Expressway, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff; and Christopher A. Wood, Attorney, of Holloway, Dobson, Hudson & Bachman, Oklahoma City, Oklahoma, appeared for the Defendant, and Defendant appeared in person.

The Board of Medical Licensure and Supervision en banc heard testimony, reviewed exhibits, and being fully advised in the premises, the Board of Medical Licensure and Supervision therefore finds as follows:

FINDINGS OF FACT

1. That Defendant, Brent L. Wauters, M.D., holds Oklahoma Medical License No. 12751.
2. That the Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
3. That following notice and hearing on September 15, 1988, the Defendant was placed on probation to the Oklahoma State Board of Medical Licensure and Supervision for a period of three years under certain enumerated terms and conditions.
4. That in the time since imposition of probation on September 15, 1988, the Defendant did comply with terms and conditions of probation in all respects.
5. That the Request for Termination of Probation filed with the Board on October 20, 1989, and containing Exhibits A-D, represents evidence of the Defendant's compliance with the terms and conditions of probation.
6. That continuation of the probation is not necessary to protect public health, safety and welfare, and said probation should be terminated and the Defendant commended for his compliance therewith.

CONCLUSIONS OF LAW

1. That the Oklahoma Board of Medical Licensure and Supervision has lawful jurisdiction over the Defendant pursuant

to the Oklahoma Medical Practice Act, 59 O.S. Supp. 1988, Sec. 481 et seq., and termination or modification of probation is a matter within the Board's exercise of discretion and may be granted in any case where the Board finds sufficient evidence.

ORDER


IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

1. That the three-year probation of the Defendant, Brent L. Wauters, M.D., holding Oklahoma Medical License No. 12751, beginning on September 15, 1988, should be and the same is hereby TERMINATED.




