FINAL ORDER

This cause came on for hearing before the Oklahoma Board of Medical Examiners en banc on January 13, 1984, at 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the Rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff and Bradley Harbin, M.D., did not appear either in person or by representative.

The Board of Medical Examiners en banc heard the testimony and reviewed exhibits and being fully advised in the premises therefore finds as follows:

FINDINGS OF FACT

1. That Bradley Harbin, M.D., holds Oklahoma Medical License No. 12769.
2. That the Board of Medical Examiners en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the Rules of the Board.
3. That the Defendant did on December 9, 1983, agree to accept service of the Citation and Complaint by certified mail, return receipt requested, and said material was mailed on that date to him at his present address of 208 Meadow Lane, Hot Springs, Arkansas 71913, and the return receipt card from the post office indicates that said material was received by the Defendant on December 16, 1983, and that the Defendant did thereafter prepare a response to the Complaint and Citation in the form of a letter dated December 19, 1983, and received by the State Board of Medical Examiners' staff on December 27, 1983.
4. That on or around December 1, 1983, Defendant pled guilty to possession of cocaine in violation of 21 U.S.C. §844a and possession of a loaded firearm in a National Park and interfering with law enforcement officers on federal property in the United States Federal Court for the Western District of Arkansas, and thereafter was sentenced on or around December 1, 1983, on those two matters in Case Nos. 83-60012-01 and 83-60013-01.
5. That on or around November 18, 1980, Defendant pled guilty to the criminal charge of grand larceny in the District Court of Tulsa County, Oklahoma, and thereafter was sentenced on or around November 18, 1980, in Case No. CRF-80-3017.
6. That the Court Clerk for the United States District Court for the Western District of Arkansas and the Court Clerk for the District Court for the Fourteenth Judicial District in

Tulsa County, State of Oklahoma, both forwarded to the State Board of Medical Examiners the certificates certifying that the aforesaid pleas of guilty had been filed on the aforesaid dates and that their respective court files do not reflect any appeal taken therefrom and that the respective pleas of guilty had become final.

CONCLUSION OF LAW

1. That Bradley Harbin, M.D., holding Oklahoma Medical License No. 12769, is in violation of the Oklahoma Medical Practice Act, 59 O.S. 1981, §509, Paragraphs 6 and 8, to-wit:


- "6. Conviction of a felony or of any offense involving moral turpitude."
- "8. Conviction or confession of a crime involving the violation of the antinarcotic . . . laws and regulations of the Federal Government"

ORDER

IT IS THEREFORE ORDERED by the Board of Medical Examiners of Oklahoma as follows:

- 1. That Medical License No. 12769 held by Bradley Harbin, M.D., should be and is hereby revoked.
- 2. That the Defendant shall be notified of this action as soon as possible by the staff of the State Board of Medical Examiners.
