**ORDER DENYING REINSTATEMENT OF  
MEDICAL LICENSE**

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision on September 16, 2010, at the Board office, 101 N.E. 51<sup>st</sup> Street, Oklahoma City, Oklahoma 73118, pursuant to notice given as required by law and rules of the Board.

Rogelio Bombach, Applicant, appeared in person and pro se.

Elizabeth A. Scott, Assistant Attorney General, appeared on behalf of the State of Oklahoma, ex rel. the Oklahoma State Board of Medical Licensure and Supervision.

The Board *en banc* reviewed the exhibits presented, and being fully apprised of the premises, entered the following Findings of Fact, Conclusions of Law, and Orders:

***FINDINGS OF FACT***

1. Applicant previously held Oklahoma Medical License No. 12832.
2. On May 20, 2010, the Board revoked Applicant's license for unprofessional conduct in violation of 59 O.S. §509(7), (13) and (17), and OAC Title 435:10-7-4(23), (39) and (44).
3. Applicant has applied for reinstatement of his license.
4. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.

**CONCLUSIONS OF LAW**


1. The Board has jurisdiction over the subject matter herein pursuant to 59 O.S. §480 et seq.
2. The Applicant has failed to sustain his burden of proof that he has met all requirements for reinstatement of his medical license at this time, including but not limited to the requirements that he is professionally competent and of good moral character.

**ORDER**

**IT IS THEREFORE ORDERED** by the Board of Medical Licensure and Supervision as follows:


1. Applicant's request for reinstatement of his medical license shall be **DENIED**
