ORDER TERMINATING PROBATION

This matter came on for hearing before the Oklahoma State Medical Board of Licensure and Supervision on September 12, 2013, at the office of the Board, 101 N.E. 51st Street, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board. Defendant, Eric Lee Cottrill, M.D., appeared in person.

The Board *en banc* heard testimony, reviewed the Motion and being fully apprised of the premises, entered the following Findings of Fact, conclusions of Law, and Orders:

Findings of Fact

- 1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and rules of the Board.
- 2. On May 21, 2009, after a hearing before the Board *en banc*, the Board entered an Order Accepting Voluntary Submittal to Jurisdiction based upon allegations of misconduct contained in the complaint filed April 17, 2009.
- 3. Defendant is seeking to terminate the probation which commenced on May 21, 2009.
- 4. After hearing testimony the Board has determined that it is appropriate to terminate

Defendant's probation.

Conclusions of Law

- 1. The Board has jurisdiction to reinstate the license of a physician pursuant to 59 O.S. §508.1
- 2. The Board may impose practice parameters and other restrictions as necessary to protect the health, safety and welfare of the public under 59 O.S. §480 et seq. The Board may also modify, or remove entirely, previously placed restrictions.

<u>Order</u>

It is therefore **ORDERED** by the Board of Medical Licensure and Supervision as follows

1. Defendant's probation, the terms of which are described in the Order Accepting Voluntary Submittal to Jurisdiction dated May 21, 2009, is hereby terminated.
