VOLUNTARY SUBMITTAL TO JURISDICTION

COMES NOW the above-name Defendant, Stephan A. Kostiuk, M.D. (hereinafter referred to as "Defendant"), who holds Oklahoma Medical License No. 13231, and states as follows, to-wit:

(a) That he is of sound mind and is thinking clearly and handling his own affairs.

(b) That he is not under the influence of alcohol or any drug or medication or impaired therefrom.

(c) That he has not been coerced or threatened in any way as regards to this proceeding.

(d) That he takes the following action voluntarily, of his own volition, fully understanding its consequences.

(e) That he is fully aware of the Complaint and Citation served upon him and acknowledges lawful service thereof.

(f) That he has been advised and understands his right to appear before the Oklahoma Board of Medical Licensure and Supervision en banc for evidentiary hearing, pursuant to 59 O.S. Supp. 1988, Section 504-507, on allegations raised in the Complaint and Citation.

After carefully considering the allegations made in the Citation and Complaint and weighing the potential evidence, the Defendant waives his right to an evidentiary hearing before the Oklahoma Board of Medical Licensure and Supervision. The Defendant neither admits nor denies, but chooses not to contest the allegations of the aforesaid Compliant and voluntarily submits to the jurisdiction of the Oklahoma State Board of Medical Litensure and Supervision insofar as it entails the following activities and restrictions:

1. That Defendant accepts and agrees to and does hereby begin a term of voluntary probation to the Oklahoma State Board of Medical Licensure and Supervision to continue for a period of five (5) years, unless earlier modified by the Board, on its own motion or on the motion of the Defendant, under the following terms and conditions:

- (a) During the period of probation Defendant will not be allowed to prescribe, dispense, or administer controlled dangerous substances as listed in the Oklahoma Uniform Controlled Dangerous Substances Act.
- (b) During the period of probation Defendant will not prescribe, administer or dispense any medications for his personal use, to specifically include controlled dangerous substances.
- (c) During the period of Probation Defendant will take no medication except that which is authorized by a physician treating him for a legitimate medical need and Defendant shall have an affirmative duty to inform any physiciantreating him of Defendant's previous chemical dependency.
- (d) During the period of probation Defendant will abstain from consuming alcohol or any substance, specifically including but not limited to controlled dangerous substances, which would adversely affect his ability to practice medicine or surgery as interpreted by the Oklahoma State Board of Medical Licensure and Supervision.
- (e) During the period of probation Defendant will submit biological fluid specimens to include, but not limited to, blood and urine, for analysis, upon request of any investigator or other agent representing the Oklahoma State Board of Medical Licensure and Supervision, and Defendant will pay for testing and analysis of those specimens.
- (f) During the period of probation Defendant will furnish to the office of the State Board of Medical Licensure and Supervision all current legal addresses and any change of address in writing.
- (g) That Defendant shall appear before the Board or a designated member whenever requested to do so.
- (h) During the period of probation Defendant will submit to the Investigation Division of the Oklahoma State Board of

Medical Licensure and Supervision any required reports and forms on a timely and prompt basis.

- Pursuant to Section 26, H.b. 1478, 1987 Legislature, Defendant shall promptly (i) pay upon receipt of invoice from the Investigation Division of the Board the costs of investigation, prosecution and probation of this case.
- During the period of probation Defen-dant shall notify any hospital where he holds staff privileges, or clinic, or (j) group where he practices, of the terms and conditions of this Board Order and supply a copy thereof.
- Defendant agrees to participate in such (k) recovery programs as may be recommended by Dr. J. Darrel Smith, Director of the Oklahoma State Medical Association Physician's Recovery Program.
- (1)That violation of any of the terms and conditions of probation shall be grounds for additional charges to be presented to the board after notice to the Defendant.

2. That the jurisdiction of the Board in this individual proceeding will continue until the terms and conditions of probation are modified or lifted by the Oklahoma Board of Medical Licensure and Supervision on their own motion or on the motion of the Defendant.

The Defendant further agrees that failure to meet any 3. of the above terms of probation will constitute cause for the Board to initiate additional proceedings to suspend or revoke Defendant's Oklahoma Medical License, after additional due notice and hearing.
