ORDER MODIFYING PROBATION

This matter came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on November 3, 2011, at the Board office, 101 N.E. 51st street, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board.

Applicant, Lori Hansen, M.D., holding Oklahoma medical license no. 13287, appeared not.

Elizabeth A. Scott, Assistant Attorney General, appeared on behalf of the State of Oklahoma.

The Board sitting *en banc* after hearing testimony, reviewing the request and other materials presented, and being fully apprised of the premises, made the following Findings of Fact, Conclusions of Law and Orders:

FINDINGS OF FACT

1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.
2. Dr. Hansen currently holds medical license no. 13287 under an indefinite term of probation that commenced on September 20, 2007.
3. On July 22, 2010, Dr. Hansen requested that her probation be terminated so that she could join the American Academy of Cosmetic Surgery. The Board denied her request.

4. On September 15, 2011, Dr. Hansen requested that her probation be terminated so that she could join one of her professional organizations and so that she could apply for hospital privileges. The Board denied her request.

5. On November 3, 2011, the State requested that the terms of Dr. Hansen's probation be modified so that Dr. Hansen would no longer be required to send in duplicate, serially prescriptions for controlled dangerous substances on a monthly basis due to the State's use of the Prescription Monitoring Program.

6. The State presented sufficient evidence to support the requested modification.

CONCLUSIONS OF LAW

1. The Board has jurisdiction to hear this matter pursuant to 59 O. S. § 480 *et seq.*

2. The State has presented satisfactory evidence to justify modifying Dr. Hansen's probation whereby Dr. Hansen would no longer be required to send in duplicate, serially prescriptions for controlled dangerous substances on a monthly basis due to the State's use of the Prescription Monitoring Program.

ORDER

IT IS THEREFORE ORDERED by the Board of Medical Licensure and Supervision as follows:


1. The State's application to modify the terms of Dr. Hansen's probation is **GRANTED**.

2. Dr. Hansen's probation shall continue indefinitely from the date of its commencement of September 20, 2007 under the terms and conditions set forth in the September 20, 2007 Order, with the exception that Dr. Hansen will no longer be required to send in duplicate, serially prescriptions for controlled dangerous substances on a monthly basis due to the State's use of the Prescription Monitoring Program.

3. Failure to meet any of the terms of this Order will be grounds for the Board to initiate proceedings to suspend or revoke Dr. Hansen's medical license, after additional notice and hearing as required by law.

4. A copy of this written order should be sent to Dr. Hansen as soon as it is processed.


