YOU ARE HEREBY NOTIFIED that on the 19 day of August, 1992, a sworn Amended Complaint was filed with the undersigned member of the Oklahoma State Board of Medical Licensure and Supervision, State of Oklahoma, charging you with violation of the Oklahoma Medical Practice Act, 59 O.S. 1991, Sec. 509, Paragraph 9. A copy of said Amended Complaint is attached hereto and made a part hereof.

On the 16 day of October, 1992, said Board will be in regular session at 1:00 o'clock P. M., at 5104 N. Francis, Suite C, Oklahoma City, OK, at which time said Amended Complaint will be considered by the Board and a hearing will be held pursuant to the Oklahoma Administrative Procedures Act, 75 O.S. 1971, Sec. 301, et seq., as amended.


If it be the decision of the Board, after considering all the testimony and evidence, that you are guilty as charged, your license to practice medicine and surgery within the State of Oklahoma will be suspended or revoked or such other disciplinary action taken by the Board as may be authorized by law.

Under the laws of the State of Oklahoma, you are required to file your written Answer under oath with the Secretary of said

Board within twenty (20) days after the Amended Citation is served upon you. Unless said Answer is so filed, you will be considered in default and if the charges be deemed sufficient by the Board your license to practice medicine and surgery in the State of Oklahoma will be suspended or revoked.

THEREFORE, you are cited to appear at said hearing on said date. If you are not present in person, you may be present by your attorney or other representative.
