**FINAL ORDER OF SUSPENSION**

This cause came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision (the "Board") on November 20, 2003, at the office of the Board, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Elizabeth A. Scott, Assistant Attorney General, appeared for the plaintiff and defendant appeared not.

The Board *en banc* after hearing arguments of counsel, reviewing the pleadings filed, and being fully advised in the premises, found that there is clear and convincing evidence to support the following Findings of Fact, Conclusions of Law and Orders:

***Findings of Fact***

1. The Board is a duly authorized agency of the State of Oklahoma empowered to license and oversee the activities of physicians and surgeons in the State of Oklahoma pursuant to 59 Okla. Stat. §480 *et seq.*
2. The Board has jurisdiction over this matter, and notice has been given in all respects in accordance with law and the rules of the Board.
3. Defendant, Patricia Mae Lindsay, M.D., holds Oklahoma license no. 13160.
4. On or about October 17, 2003, Defendant was ordered by the

Maricopa County Superior Court, State of Arizona, into an inpatient mental health treatment at a local mental health treatment facility in Maricopa County, Arizona based upon a finding that she is suffering from a mental disorder and is persistently or acutely disabled, is in need of treatment and is either unwilling or unable to accept voluntary treatment.

*Conclusions of Law*


1. The Board has jurisdiction and authority over the Defendant and subject matter herein pursuant to the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act (the "Act") and its applicable regulations. The Board is authorized to enforce the Act as necessary to protect the public health, safety and welfare.

*Order*

IT IS THEREFORE ORDERED by the Oklahoma State Board of Medical Licensure and Supervision as follows:


1. The license of Defendant, Patricia Mae Lindsay, M.D., Oklahoma license no. 13160, is hereby **SUSPENDED** beginning November 20, 2003 and continuing until she is able to appear before the Board, at which time a hearing on the Complaint and Citation will be held.
2. Promptly upon receipt of an invoice, Defendant shall pay all costs of this action authorized by law, including without limitation, legal fees and investigation costs.
3. Defendant's suspended license shall not be reinstated unless Defendant has reimbursed the Board for all taxed costs.
