**Findings of Fact**

1. The Board *en banc* has jurisdiction over the subject matter herein and notice has been given in all respects as required by law and the rules of the Board.



The Board has legal authority to table an application when evidence on the application is insufficient to allow evaluation by the board to make a final judgment as to whether the Applicant fulfills the requirements of 59 Okla. Stat. §481 *et seq.*, and the applicable rules of the Board to qualify for licensure in Oklahoma as a physician and surgeon.

**Order**

It is therefore **ORDERED** by the Oklahoma State Board of Medical Licensure and Supervision as follows:


1. The Application of **GREGORY KEITH MORTON** for reinstatement of his full medical licensure in Oklahoma as a physician and surgeon should be **TABLED** pending an appearance before the Board.
