ORDER MODIFYING PROBATION

This matter came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on May 20, 2010, at the Oklahoma State Medical Association, 313 N.E. 50th Street, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board.

The State was represented by Elizabeth A. Scott, Assistant Attorney General. Lynn Dean Baggett, M.D., holding Oklahoma medical license no. 14448, appeared not.

The Board sitting *en banc* after hearing testimony, reviewing the request and other materials presented, and being fully apprised of the premises, made the following Findings of Fact, Conclusions of Law and Orders:

FINDINGS OF FACT

1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.
2. Dr. Baggett currently holds medical license no. 14448 under a five-year term of probation that commenced November 6, 2008.

3. On November 19, 2009, Dr. Baggett requested that the terms of his probation be modified to allow him to prescribe Suboxone and Subutex. The Board granted Dr. Baggett's request.

4. On May 20, 2010, the State, on behalf of Dr. Baggett, requested that the terms of Dr. Baggett's probation be modified to allow his work location to be changed if approved by the Board Secretary.

5. The State presented sufficient evidence to support the requested modification.

CONCLUSIONS OF LAW

1. The Board has jurisdiction to hear this matter pursuant to 59 O. S. § 480 *et seq.*

2. The State has presented satisfactory evidence to justify allowing Dr. Baggett's work location to be changed if approved by the Board Secretary.

ORDER

IT IS THISEFORE ORDERED by the Board of Medical Licensure and Supervision as follows:


1. The State's application to modify the terms of Dr. Baggett's probation is **GRANTED**.

2. Dr. Baggett's probation shall continue for five (5) years from the date of its commencement of November 6, 2008 under the terms and conditions set forth in the November 6, 2008 Order as filed on November 21, 2008, then as modified by the November 19, 2009 Order Modifying Probation as filed December 4, 2009, with the exception that Dr. Baggett is allowed to change his work location if approved by the Board Secretary.

3. Failure to meet any of the terms of this Order will be grounds for the Board to initiate proceedings to suspend or revoke Dr. Baggett's medical license, after additional notice and hearing as required by law.

4. A copy of this written order should be sent to Dr. Baggett as soon as it is processed.


