FINAL ORDER  
DISMISSING COMPLAINT

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on June 26, 1992, at the office of the Oklahoma State Board of Medical Licensure and Supervision, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff; and Nareshkumar Patel, M.D., Defendant, appeared in person and by counsel, Stanley M. Ward, Attorney at Law, 629 - 24th Ave. SW, Norman, OK 73069.

The Board of Medical Licensure and Supervision en banc heard testimony, reviewed exhibits and being fully advised in the premises, the Oklahoma Board of Medical Licensure and Supervision finds as follows:

FINDINGS OF FACT

1. That Defendant, Nareshkumar Patel, M.D., holds Oklahoma Medical License No. 14640.
2. That the Oklahoma Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
3. That Plaintiff failed to present a preponderance of evidence to demonstrate unprofessional conduct as defined in the Oklahoma Medical Practice Act, 59 O.S. 1991, Sec. 509, and the rules and regulations adopted by the Board.
2. That in light of the evidence received and the requirements of 59 O.S. 1991, Sec. 509, said Complaint should be dismissed.

CONCLUSIONS OF LAW

1. That the evidence presented did not show unprofessional conduct as defined by the Oklahoma Medical Practice Act, 59 O.S. 1991, Sec. 509.


ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:




