FINAL ORDER

This cause came on for hearing before the Oklahoma Board of Medical Examiners en banc on January 19, 1985, at 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the Rules of the Board.

Daniel J. Gamino, attorney, appeared for the Plaintiff, and Michael Britton Beason, M.D., appeared in person, pro se, for the Defendant.

That the Defendant and counsel for the Plaintiff then advised the Board of Medical Examiner, of a proposed disposition of this case. Said proposal is hereby adopted and the Board of Medical Examiners makes the following Findings of Fact, Conclusions of Law, and Order:

FINDINGS OF FACT

1. That Michael Britton Beason, M.D., holds Oklahoma Medical License No. 14702.
2. That the Board of Medical Examiners en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the Rules of the Board.
3. That on or around October 25, 1984, the Defendant Michael Britton Beason, did voluntarily advise investigators of the State Board of Medical Examiners that he had been abusing the drug Darvon, a Schedule IV controlled dangerous substance for at least three years and that his present tolerance for the drug was 10 to 15 tablets daily and that he had obtained the drugs through prescriptions written by himself for his wife and himself and the prescriptions were then presented to various pharmacies in the area of Chickasha,

Oklahoma, where the Defendant practiced and were usually written for 20 to 30 tablets each.

4. That on or around October 29, 1984, the Defendant voluntarily entered the drug rehabilitation program at Hartview Center, 1406 Second Street, N.W., Mandan, North Dakota 58554, and that the discharge summaries and other materials therefrom indicate that the Defendant successfully completed the inpatient portion of that program.

5. That the Defendant has voluntarily entered the aftercare program at the Norman Alcohol Information Center under the direction of Father Dick Virtue and is attending the center at least once a week accompanied by his wife.

CONCLUSIONS OF LAW

1. That the evidence shows the Defendant to be in violation of 59 O.S. 1981, Section 509, Paragraph 5, and Section IX, Rule 3 of the Rules and Regulations promulgated by the Board of Medical Examiners.

ORDER


IT IS THEREFORE ORDERED by the Board of Medical Examiners of Oklahoma as follows:

1. That the Defendant Michael Britton Beason, M.D., Oklahoma Medical License No. 14702, will be and is hereby placed on probation to the Oklahoma State Board of Medical Examiners for a period of three (3) years beginning on January 19, 1985, under the following terms and conditions:

- a) That during the period of probation it is required that Dr. Beason comply with the Oklahoma Medical Practice Act as interpreted by the Oklahoma State Board of Medical Examiners and that he appear before the Board or its designated representative upon request.
- b) During the period of probation Dr. Beason will submit biological fluid specimens to include, but not limited to, blood and urine, for analysis upon the request of any inspector or other agent representing the Oklahoma State Board of Medical Examiners.
- c) During the period of probation Dr. Beason will take no scheduled drug or alcohol except that which is authorized by a physician treating him for a legitimate medical need and the Defendant has the specific responsibility of advising any treating physician of his complete medical history, including his use of the drug Darvon.


- d) During the period of probation Dr. Beason will furnish to the office of the State Board of Medical Examiners all current legal addresses and any change of address in writing.
- e) Dr. Beason shall furnish to the Board of Medical Examiners a summary of his treatment plan and his plans for continued treatment and all medical records of treatment that has been rendered to him to date.
