
**SECOND NUNC PRO TUNC ORDER AMENDING AND CORRECTING
NOVEMBER 12, 1998 VOLUNTARY SUBMITTAL TO JURISDICTION**

At the request of Defendant, William G. Wiggs, this *Second Nunc Pro Tunc Order* amending and correcting the November 12, 1998 Voluntary Submittal to Jurisdiction is entered to clarify and affirmatively state the commencement date of the ninety (90) day period of suspension imposed upon Defendant by the Oklahoma State Board of Medical Licensure and Supervision in the Voluntary Submittal to Jurisdiction entered November 12, 1998 in this case. Defendant's period of suspension shall run from December 1, 1998 to February 28, 1999; provided that Defendant completes a course approved by the Board or its designee on pain management and record keeping and submits satisfactory evidence to the Board or its designee of such completion.¹

¹ Defendant, prior to the entry date of this order, has submitted satisfactory evidence to the Board Secretary of his attendance at an approved course on pain management and record keeping.


