**VOLUNTARY SURRENDER OF LICENSE
IN LIEU OF PROSECUTION**

I, Logan William Bellew, Provisional Respiratory Care practitioner, being of lawful age and after first being duly sworn, depose and state as follows:

1. I hereby voluntarily surrender my Provisional Respiratory Care license no. 1484
2. The surrender of my license is freely and voluntarily made. I have not been subject to any coercion or duress, and I am fully aware of the consequences of the surrender of my license.
3. I am the subject of an investigation by the Oklahoma State Board of Medical Licensure and Supervision involving allegations that if proven, would constitute grounds for disciplinary action by the Board.
4. The allegations to which I have pled guilty are as follows:

History with the Board

5. On November 22, 2013, Defendant, due to his history of alcohol-related arrests, was placed under Agreement for Licensure by the Board .
6. On June 25, 2014, Defendant was terminated from his employment with St. Johns,

Owasso, Oklahoma.

Violation of Probation

7. On June 30, 2014, Defendant stopped checking in with Affinity, stopped attending all OHPP meetings and counseling sessions, and did not notify Board Compliance Coordinator of his condition.

8. On July 30, 2014, Defendant was contacted by Board Compliance Coordinator. Defendant stated he was unable to work due to a lower back injury and the necessary pain medication made it unsafe for him to drive. Defendant requested he be allowed to sign a Surrender in Lieu of Prosecution.

9. Defendant is in violation of the following paragraphs of the Agreement for Licensure entered into on November 22, 2013:

Paragraph B: Applicant will submit for analysis biological fluid specimens.

Paragraph J: Any violation of the terms, conditions and requirements of this Agreement shall constitute conclusive evidence of unprofessional or dishonorable conduct, which may result in disciplinary action, including suspension or revocation.

Paragraph P: Applicant will submit any required reports and forms on a timely, accurate and prompt basis to the Compliance Coordinator or designee.

Paragraph R: Applicant will attend counseling approved by the Board Secretary. Said counseling shall continue until such time as Board Secretary and counselor deem it on longer necessary.

Paragraph S: Applicant will follow all recommendations resulting from the assessment performed by The Medical Group on May 2, 2013.

10. Defendant is guilty of unprofessional conduct in that he is in:

Violation of any provision(s) of the medical practice act or the rules and regulations of the Board or of any action, stipulation or

agreement of the Board as stated in *Oklahoma Administrative Code Rule 435:10-7-4 (39)*.

Do not have a wall certificate.

11. I hereby submit my wallet card and wall certificate as evidence of my intent to surrender my license.

12. I hereby agree that I will not apply for reinstatement of my Oklahoma Provisional Respiratory Care license for a minimum of one year from the entry of the Order Accepting Voluntary Surrender in Lieu of Prosecution, and that if the Board ever reinstates my Oklahoma Provisional Respiratory Care license, it will be under terms of probation to be set by the Board at the time of reinstatement.

13. As a condition to accepting my surrender of license in lieu of prosecution, I acknowledge that the Board may require me to pay all costs expended by the Board for any legal fees and costs, expended by the Board for any legal fees and costs, and any investigation, probation and monitoring fees, including but not limited to staff time, salary and travel expense, witness fees and attorney fees.

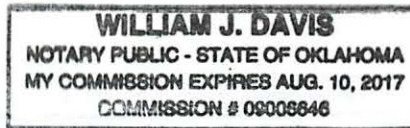
