ORDER VACATING ORDER OF SUSPENSION

Having reviewed the Petition to Reconsider and Vacate Order, the Board, by vote of six (6) to one (1), finds that the defendant's Petition to Reconsider and Vacate Order should be sustained and that the Board's Order of Suspension, entered on May 15, 1997, and filed of record on May 16, 1997, should be vacated and the the above-styled case should be restored to the status existing immediately prior to the entry of the aforesaid Order of Suspension, i.e., that the Defendant's Agreement not to practice medicine pending final disposition of this case remains in full force and effect.

Further, the Board finds that this case should be set on the July 24-26, 1997, docket for trial on the merits or other disposition as may be approved by the Board.




