ORDER OF REINSTATEMENT

NOW ON this 27th day of January, 1995, there comes on before the Oklahoma Board of Medical Licensure and Supervision (the "Board") the application of the defendant, Mark R. Lynn, for the reinstatement of his license to practice medicine and surgery in the State of Oklahoma.

FINDINGS OF FACT

1. The Board, having heard the evidence presented in the matter, the testimony of the witnesses, and otherwise being apprised of the facts and record herein, finds that the application for reinstatement should be granted, subject to certain conditions.

CONCLUSIONS OF LAW

- 1. The Board has jurisdiction in this matter pursuant to the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act, 59 O.S.1991, §§ 481, et seq., as amended;
- 2. In an application for reinstatement by the Board, the burden is upon the defendant to prove the defendant's ability to practice medicine and surgery with reasonable skill and safety. <u>Id</u>.

ORDER

- It is therefore ORDERED that the medical license of the defendant, Mark R. Lynn, is hereby reinstated as follows:
- 1. The defendant is granted a special license for a period of three (3) months during which time the defendant shall practice solely and exclusively in a "mini-internship" as described by the defendant to the Board in the hearing on this matter;
- 2. The defendant shall reappear before the Board within three months of the date of this Order to present to the Board definite future practice plans, at which time the defendant's application for reinstatement shall be reconsidered;
- 3. The defendant shall not enter any internship which involves emergency room practice or anesthesiology;
- 4. The defendant shall continue in the recommended recovery steps of the Physician's Recovery group, to include:
 - a. not returning to practice anesthesiology;
 - b. obtaining 30 hours of continuing medical education;
 - c. work (unpaid) under a preceptor for three months;
 - d. work half time in the initial six months of Primary Care Practice:
 - continue in the Physician's Recovery Program to include:
 - a. weekly urine monitoring;
 - b. continued psychiatric monitoring and weekly group therapy;
 - c. attendance at a minimum of three (3) AA meetings per week;
 - d. continue attendance of the Caduceus Group.
- 5. During the period of temporary licensure, the defendant shall not prescribe, dispense or administer any narcotics.
- 6. The defendant shall identify to the staff of the Board specific details of the internship entered into by the defendant, which internship the staff may review and inspect. The defendant

shall provide the staff of the Board with additional information upon request.
