ORDER RESTORING UNMODIFIED
OKLAHOMA MEDICAL LICENSE

The Defendant's application for unmodified license came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on May 19, 1990, at the office of the Oklahoma Board of Medical Licensure and Supervision, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff; and Marvin B. York, Attorney, 515 Central Park Drive, Suite 311, Oklahoma City, Oklahoma 73105, appeared for the Defendant.

The Board of Medical Licensure and Supervision en banc reviewed exhibits, heard testimony, and being fully advised in the premises, the Board of Medical Licensure and Supervision finds as follows:

FINDINGS OF FACT

1. That Defendant, Terrence E. Murphy, M.D., holds Oklahoma Medical License No. 14919.
2. That the Oklahoma Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
3. That on or around January 13, 1990, following notice and hearing, application of Terrence E. Murphy for reinstatement as a licensed physician and surgeon in Oklahoma was granted by the Board and Dr. Murphy was placed on probation to the Oklahoma Board of Medical Licensure and Supervision for a period of three years beginning on January 13, 1990, under certain enumerated terms and conditions.
4. That since that date Dr. Murphy has fulfilled terms and conditions as set forth by the Board and functioned as a licensed physician.
5. That evidence presented by Dr. Murphy was sufficient to show that Dr. Murphy could function as a medical doctor with an unmodified license without endangering public health, safety or welfare.
6. Dr. Murphy agreed in the event his license was restored to an unmodified state, that in the event he returned to Oklahoma to practice he would appear before the Board and follow any additional terms and conditions imposed, if any, and further Dr.

Murphy agreed to submit to the normal Oklahoma Board post-probation visit.

CONCLUSIONS OF LAW

1. That the Defendant is under the continuing jurisdiction of the Oklahoma Board of Medical Licensure and Supervision and reinstatement of Dr. Murphy's license to an unmodified status is within the discretion and judgment of the Board.

ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

1. That the application of Terrence E. Murphy, M.D., for termination of probation and an unmodified Oklahoma medical license should be and the same is hereby GRANTED.

2. That the three year probation beginning on January 13, 1990, is specifically set aside and held for naught.

3. In the event Dr. Murphy returns to active practice in Oklahoma, he will appear before the Oklahoma Board and comply with any terms and conditions imposed at that time, if any, and will submit to the normal post-probation visit by the Board staff.
