**ORDER TERMINATING INDEFINITE PROBATION**

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision (“Board”) on November 5, 2020, at the office of the Board, 101 N.E. 51<sup>st</sup> Street, Oklahoma City, Oklahoma 73105, pursuant to notice given as required by law and the rules of the Board.

Gary Ricks, Compliance Coordinator for the Board, appeared on behalf of Plaintiff. Bruce Stewart Gilmore, M.D. appeared in virtual person, *pro se*.

The following witnesses were sworn and testified: Dr. Paul Cheng, M.D., Associate Director of Oklahoma Health Professionals Program (“OHPP”) and Gary Ricks, Compliance Coordinator.

The Board, having heard testimony, considered representations of Mr. Ricks and being fully apprised of the premises, makes the following findings of fact, conclusions of law and orders:

**Findings of Fact**

1. In Oklahoma, Defendant holds medical license no. 15474, originally issued August 19, 1985.
2. On January 27, 2012, a Complaint was filed by the Board based upon violation of the indefinite probation terms set forth in the Order Granting Reinstatement of License Under Terms of Probation entered herein on May 21, 2009.
3. On May 17, 2012 a Final Order of Revocation (“2012 Order of Revocation”) was entered, which was filed on May 25, 2012.

4. On May 16, 2013, an Order Granting Reinstatement of License Under Terms of Indefinite Probation ("2013 Order Granting Reinstatement Under Indefinite Probation"), was entered with terms and conditions of INDEFINITE PROBATION including a lifetime contract with the Health Professionals Recovery Program.
5. On October 7, 2020, Defendant requested to terminate his indefinite probation.
6. At the November 5, 2020, Dr. Cheng, testified that Dr. Gilmore has a good recovery program, and has received his Board certification during this time.
7. Mr. Ricks testified that Dr. Gilmore has complied with all the requirements of the 2013 Order Granting Reinstatement Under Indefinite Probation, all test results have been negative, and Dr. Gilmore recently signed a new lifetime contract to the Oklahoma Health Professionals Program (OHPP). Mr. Ricks further testified that based on his good compliance, Board staff supports Dr. Gilmore's motion to terminate his indefinite probation.
8. Any conclusion of law below which is more properly characterized as a finding of fact is hereby incorporated as a finding of fact.

#### Conclusions of Law

9. The Board has jurisdiction over the subject matter and is a duly authorized agency of the State of Oklahoma empowered to license and oversee the activities of physicians and surgeons in the State of Oklahoma. 59 O.S. § 480 *et seq.*, 59 O.S. 492 *et seq.*; Okla. Admin. Code §§ 435:5-1-1 *et seq.*, 435:10-4-2.
10. Notice was provided as required by law and the rules of the Board. 75 O.S. § 309; 59 O.S. § 504; Okla. Admin. Code §§ 435:3-3-5, 435:3-3-6.

#### Orders

**IT IS THEREFORE ORDERED** by the Oklahoma State Board of Medical Licensure and Supervision as follows:

11. The **BRUCE STEWART GILMORE, M.D.** motion to terminate indefinite probation is **GRANTED**.
12. A copy of this Order shall be provided to Defendant as soon as it is processed.
