FINAL ORDER

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on October 2, 1993, at the office of the Oklahoma State Board of Medical Licensure and Supervision, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff; and Timothy Brian Jones, M.D., Defendant, appeared in person, pro se, waived his right to counsel, and announced ready to proceed.

That the Oklahoma Board of Medical Licensure and Supervision en banc heard testimony, reviewed exhibits and being fully advised in the premises, the Oklahoma Board finds and orders as follows:

FINDINGS OF FACT

1. That Defendant, Timothy Brian Jones, M.D., holds Oklahoma Medical License No. 15714.
2. That the Oklahoma Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
3. That on or around March 22, 1993, this agent was advised that the mailing address of the Defendant on file with this Board, 8600 S. Pennsylvania, Oklahoma City, OK 73159, was not current and that the Defendant failed to notify the Board that his previously reported address of 8600 S. Pennsylvania, Oklahoma City, OK 73159, was out of date.
4. That on or around May 19, 1993, Defendant was served with an Administrative Citation and fined \$75.00 pursuant to the legal authority of Board Rule 435:10-7-3. On or around May 21, 1993, Defendant requested an evidentiary hearing.

CONCLUSIONS OF LAW

1. That Timothy Brian Jones, M.D., holding Oklahoma Medical License No. 15714, is in violation of the Oklahoma Medical Practice Act, 59 O.S. 1991, Sec. 500, to-wit:

"Every person holding a license or certificate authorizing him to practice medicine and surgery in this State shall also notify the State Board of Medical Licensure

and Supervision, in writing, of their current practice location and mailing address."

ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

1. That the Defendant, Timothy Brian Jones, M.D., holding Oklahoma Medical License No. 15714, should be and is hereby FINED in the amount of \$75.00, payable to the Oklahoma Board of Medical Licensure and Supervision.

2. Further, that the Defendant shall also pay to the Oklahoma Board of Medical Licensure and Supervision the costs of investigation and prosecution of this action.

3. That the Defendant shall receive a copy of this written Order after it is processed by the staff.
