VOLUNTARY SURRENDER OF LICENSE IN LIEU OF PROSECUTION

- I, REX EDWARD MARTIN, P.A. ("Defendant"), being of lawful age and after first being duly sworn, depose and state as follows:
- 1. I am REX EDWARD MARTIN, P.A., holding Oklahoma Medical License No. 1577.
- 2. I hereby voluntarily surrender my Oklahoma Medical License No. 1577, effective September 19, 2024. 59 O.S. 509.1(E), et seq.
- The surrender of my license is freely and voluntarily made. I have not been subject to any
 coercion or duress, and I am fully aware of the consequences of the surrender of my license.
- 4. I admit that I am the subject of a proceeding by the Oklahoma State Board of Medical Licensure and Supervision ("Board") involving allegations which, if proven, could constitute grounds for disciplinary action by the Board.
- During the course of my lifetime, I have been arrested and charged with driving my motor vehicle under the influence of alcohol on three (3) occasions. The most recent incident was in January 2024.
- I acknowledge that I may be found guilty of unprofessional conduct by violating the following rule of professional conduct:



- a. Violate any provision of the Medical Practice Act or the rules promulgated by the Board., in violation of Okla. Admin. Code § 435:15-5-11(a)(4);
 - 59 O.S. § 509(5) Conviction or confession of, or plea of guilty, nolo contendere, no contest or Alford plea to a felony or any offense involving moral turpitude;
- 7. I hereby submit my wallet card and wall certificate as evidence of my intent to surrender my license. 59 O.S. § 509.1(E)(2).
- 8. If the Board does not accept this Voluntary Surrender In Lieu of Prosecution the Plaintiff and Defendant (collectively, the "Parties") stipulate that it shall be regarded as null and void. Admissions by Defendant herein, if any, shall not be regarded as evidence against him in a subsequent disciplinary hearing. Defendant will be free to defend himself, and no inferences will be made from his willingness to have this Order accepted by the Board. The Parties stipulate that neither the presentation of the Order nor the Board's consideration of this Order shall be deemed to have unfairly or illegally prejudiced the Board or its individual members and, therefore, shall not be grounds for precluding the Board nor any individual Board member from further participation in proceedings related to the matters set forth herein.
- 9. As a condition to accepting my voluntary surrender of license in lieu of potential prosecution, I acknowledge that the Board shall require me to pay all costs expended by the Board for any legal fees and cost, any investigation, probation and monitoring fees, including but not limited to staff time, salary and travel expense, witness fees and attorney fees.
