ORDER VACATING SUSPENSION

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on June 26, 1992, at the office of the Oklahoma State Board of Medical Licensure and Supervision, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff; and Stacy E. Seikel, M.D., Defendant, appeared by and through counsel, Mona S. Lambird, Andrews Davis Legg Bixler Milsten & Price, 500 West Main, Oklahoma City, OK 73102.

The Board of Medical Licensure and Supervision en banc heard testimony, reviewed exhibits and being fully advised in the premises, the Oklahoma Board of Medical Licensure and Supervision finds as follows:

FINDINGS OF FACT

1. That Defendant, Stacy E. Seikel, M.D., holds Oklahoma Medical License No. 15792.
2. That the Oklahoma Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
3. That on or around February 29, 1992, the Board after notice by publications had a hearing and found based on information from the Florida Board of Medical Licensure that Defendant's license to practice medicine and surgery as a physician in the State of Oklahoma should be and was suspended.
4. That upon the Defendant's Motion for Reconsideration, the Board reviewed a letter from the Defendant dated June 24, 1992, and a letter of June 24, 1992, from Constance Campbell, Administrative Assistant II, Board of Medicine, Florida Board of Medicine, Department of Professional Regulation, and a letter addressed to Ms. Lambird of May 21, 1992, from Roger A. Goetz, M.D., Director, Consultant, Florida Department of Professional Regulation clarifying the active status of Dr. Seikel's medical license in the State of Florida.
5. That based on evidence presented to the Board, it is clear that the previous suspension of the Oklahoma license may be vacated without danger to public health, safety and welfare and based on an understanding of Dr. Seikel's current and active licensure status in the State of Florida where she is actively engaged in the practice of medicine and has been since 1989 this Board's suspension of the Oklahoma license should be vacated.

CONCLUSIONS OF LAW

1. That the decision to vacate suspension is within the sound discretion and judgment of the Board.

ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

1. That the Motion for Reconsideration filed by the Defendant should be and the same is hereby GRANTED.
2. That the suspension of Defendant, Stacy E. Seikel, M.D., holding Oklahoma Medical License No. 15792, should be and the same is hereby VACATED.
3. That a copy of this Order should be forwarded to the Defendant, by and through her legal counsel, as soon as possible so her file is complete in this regard.
