# ORDER TABLING APPLICATION UNTIL PERSONAL APPEARANCE

This cause came on for consideration before the Oklahoma Board of Medical Licensure and Supervision en banc on the 9th day of June, 1988, at St. Francis Hospital, Tulsa, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

The Board of Medical Licensure and Supervision en banc reviewed the application and all attached exhibits, and being fully advised in the premises the Board of Medical Licensure and Supervision therefore finds as follows:

### FINDINGS OF FACT

- 1. That John Allen McNeil is an applicant for licensure in Oklahoma as a physician and surgeon.
- 2. That the Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
- 3. That a review of medical education, professional training and personal attributes cannot be fully evaluated until the Applicant personally appears before the Oklahoma Board of Medical Licensure and Supervision en banc.
- 4. Therefore, the Board at this time makes no decision on the medical training, qualifications or personal attributes of this Applicant and will not consider the application further until the Applicant makes a personal appearance before the Board en banc.

### CONCLUSIONS OF LAW

1. That the Board may evaluate by personal appearance any applicant for licensure as a physician and surgeon in Oklahoma pursuant to the legal authority of 59 O.S. Supp. 1987, §495, and applicable rules and regulations of the Board of Medical Licensure and Supervision of Oklahoma.

#### ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

- 1. That the application of John Allen McNeil for licensure as a physician and surgeon in Oklahoma should be and the same is hereby tabled until such time as the Applicant can appear before the Oklahoma Board of Medical Licensure and Supervision en banc and present additional evidence as to the medical education, professional training and personal attributes of the Applicant.
- 2. That the Applicant should be advised of this decision in writing as soon as possible. In the event the Applicant desires to appear at the next meeting of the Oklahoma Board of Medical Licensure and Supervision that Applicant has the
