ORDER TO CONTINUE SUSPENSION

- 2. That the Oklahoma Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
- 3. That after reviewing exhibits and hearing testimony, the suspension be continued until the September 26, 27, 28, 1996 Board meeting at which time a Voluntary Submittal to Jurisdiction is to be presented.

CONCLUSIONS OF LAW

1. That the Board of Medical Licensure and Supervision has jurisdiction over this matter pursuant to 59 O.S. Sec. 480 et seq.

ORDER

It is therefore ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

- 1. That the license of Jimmy Harold Conway remain suspended until the September 26, 27, 28, 1996 Board meeting.
- 2. That during this period of suspension that Jimmy Harold Conway and his counsel meet with the Board Secretary to work out a Voluntary Submittal to Jurisdiction.
- 3. That the Voluntary Submittal to Jurisdiction be presented to the Board at the September 26, 27, 28, 1996 Board meeting.
