#### **ORDER LIFTING RESTRICTION**

This matter came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on September 16, 2010, at the Board office, 101 N.E. 51<sup>st</sup> Street, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board.

Applicant, Bill Royce Evans, P.A., holding Oklahoma physician assistant license no. PA170, appeared in person and pro se.

The Board sitting *en banc* after hearing testimony, reviewing the request and other materials presented, and being fully apprised of the premises, made the following Findings of Fact, Conclusions of Law and Orders:

### FINDINGS OF FACT

1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.

2. Mr. Evans currently holds physician assistant license no. PA170 under a Final Order dated September 30, 1983. Under this Order, Mr. Evans' license was **RESTRICTED** in that he was not allowed to provide medical services as a physician assistant in any location or facility in the absence of his approved employing physician or his approved backup physician. The Board additionally ordered that the Applicant must introduce himself to patients and patients' family members as a physician assistant and that his identity as such must be made clear.

3. On September 16, 2010, Mr. Evans requested that his restriction be lifted so as to allow him to practice under the supervision required for physician assistants with full unrestricted licenses.

4. Mr. Evans presented sufficient evidence to support lifting his restriction to allow him to practice under the supervision required for physician assistants with full unrestricted licenses.

#### CONCLUSIONS OF LAW

1. The Board has jurisdiction to hear this matter pursuant to 59 O. S. § 480 *et seq*. and §519 *et seq*.

2. Mr. Evans has presented satisfactory evidence to support lifting his restriction to allow him to practice under the supervision required for physician assistants with full unrestricted licenses.

#### **ORDER**

**IT IS THEREFORE ORDERED** by the Board of Medical Licensure and Supervision as follows:

1. Mr. Evans' application to lift the restriction on his physician assistant license is **GRANTED**.
