ORDER TOLLING
REMAINDER OF PROBATION

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on January 11, 1992, at the office of the Oklahoma Board of Medical Licensure and Supervision, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff; and Douglas Hugh Cornelius, M.D., Defendant, did not appear in person or by representative.

The Board of Medical Licensure and Supervision en banc heard testimony, reviewed exhibits, and being fully advised in the premises, the Board of Medical Licensure and Supervision therefore finds as follows:

FINDINGS OF FACT

1. That Defendant, Douglas Hugh Cornelius, holds Oklahoma Medical License No. 17459.
2. That the Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
3. That following notice and hearing on or around September 1, 1990, Defendant was granted an Oklahoma license as a physician and surgeon and that he was also placed on probation to the Oklahoma State Board of Medical Licensure and Supervision for a period of five years beginning September 1, 1990, under certain terms and conditions enumerated in that Order.
4. That since imposition of that Order, Defendant has fulfilled terms and conditions of probation.
5. That in approximately June, 1991, Defendant did not renew his Oklahoma Medical License No. 17459, and moved to Sioux City, Iowa.
6. That while the Defendant is out of the State of Oklahoma, probation previously imposed by the Board should be tolled until such time as the Defendant returns to the State of Oklahoma and makes an application for licensure.

CONCLUSIONS OF LAW


1. That the Defendant is under the lawful jurisdiction of the Oklahoma Board of Medical Licensure and Supervision pursuant to the Oklahoma Medical Practice Act, 59 O.S. Supp. 1990, Sec. 481 et seq., and the rules and regulations of the Board.
2. That the Board has jurisdiction to toll any term of probation under terms and conditions of the circumstances of a case.

ORDER


IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

1. That the Defendant's probation to the Oklahoma Board of Medical Licensure and Supervision for a period of five years, beginning September 1, 1990, is tolled, and shall remain tolled until such time as the Defendant returns to the State of Oklahoma and makes application for licensure.
2. That Defendant should receive a copy of this Order as soon as it is signed by the Secretary and processed by the Board staff.
