# FINAL ORDER OF REVOCATION OF LICENSE

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on November 19, 1993, at the office of the Oklahoma State Board of Medical Licensure and Supervision, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff; and Gail R. Williams, M.D., Defendant, appeared in person and by legal counsel, Jayne N. Montgomery, of Montgomery & Montogmery, P.O. Box 1220, Purcell, OK 73080.

That the Oklahoma Board of Medical Licensure and Supervision en banc heard testimony, reviewed exhibits and being fully advised in the premises, the Oklahoma Board finds and orders as follows:

## FINDINGS OF FACT

- 1. That Defendant, Gail R. Williams, M.D., holds Oklahoma Medical License No. 17467.
- 2. That the Oklahoma Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
- 3. That during 1992 and 1993, Defendant in the course of his practice of medicine did sexually batter and harass female professional staff and support staff members at the Joseph Harp Correctional Center.
- 4. Based on the above facts and omissions, Defendant is perpetuating significant harm to public health, safety and welfare.

#### CONCLUSIONS OF LAW

- 1. That Gail R. Williams, M.D., holding Oklahoma Medical License No. 17467, is in violation of the Oklahoma Medical Practice Act, 59 O.S. 1991, Sec. 509, Paragraph 9, to-wit:
  - "9. Dishonorable or immoral conduct which is likely to deceive or defraud the public."

### ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

- 1. That the Defendant, Gail R. Williams, M.D., holding Oklahoma Medical License No. 17467, should be and is hereby REVOKED effective on November 20, 1993.
- That a copy of this written Order should be sent to the Defendant and/or his legal counsel as soon as possible so their record is complete.
