FINAL ORDER OF REVOCATION

This cause came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision (the "Board") on November 12, 1998, at the office of the Board, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Susan Moebius Henderson, Assistant Attorney General, appeared for the Plaintiff. Defendant appeared neither in person nor by attorney but filed, prior to the date of hearing, a verified answer pleading no contest to the charges in the Complaint filed October 7, 1998 and waiving his right to a full evidentiary hearing on those charges.

The Board *en banc* after hearing arguments of counsel and reviewing the exhibits admitted and the verified answer of Defendant, and being fully advised in the premises, found there is clear and convincing evidence to support the following Findings of Fact, Conclusions of Law and Orders:

Findings of Fact

1. The Board is a duly authorized agency of the State of Oklahoma empowered to license and oversee the activities of physicians and surgeons in the State of Oklahoma pursuant to 59 Okla. Stat. §§ 480 *et seq.*

2. The Board has jurisdiction over this matter, and notice has been given in all respects in accordance with law and the rules of the Board.

Findings of Fact

1. The Board is a duly authorized agency of the State of Oklahoma empowered to license and oversee the activities of physicians and surgeons in the State of Oklahoma pursuant to 59 Okla. Stat. §§ 480 *et seq.*
2. Defendant, J. Scot Wilson, M.D., was issued Oklahoma license no. 17703.
3. On October 16, 1997 Defendant was charged in the District Court of Cherokee County, Oklahoma with five (5) counts of forcible sodomy, a felony, in violation of 21 Okla. Stat. §888. On each count, the Information charged that Defendant engaged in the act of sodomy after administering a narcotic substance to render his victims incapable of consenting or refusing to consent. Defendant pleaded no contest to four of the five felony charges and was found guilty on July 20, 1998. Defendant received ten (10) years imprisonment on each of three of the counts to be served concurrently in the custody and control of the Oklahoma Department of Corrections and a twenty (20) year suspended sentence on one count to be served consecutively following completion of the first three sentences.
4. Defendant is guilty of unprofessional conduct in that he has been convicted of a felony involving moral turpitude in violation of 59 Okla. Stat. §509(6) and (8) and OAC 435:10-7-4(10).

Conclusions of Law

1. The Board has jurisdiction and authority over the Defendant and subject matter herein pursuant to the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act (the "Act") and its applicable regulations. The Board is authorized to enforce the Act as necessary to protect the public health, safety and welfare.
2. Under 59 Okla. Stat. §513, the license of any physician whose felony conviction has become final must be suspended or revoked and canceled by the Board upon the submission of a certified copy of the judgment and sentence of the trial court and a certificate of the clerk of the trial court that the conviction has become final.
3. Defendant, J. Scot Wilson, Oklahoma medical license 17703, is guilty of unprofessional conduct based on the foregoing facts in that he has been convicted of a felony involving moral turpitude in violation of 59 Okla. Stat. §509(6) and (8) and OAC 435:10-7-4(10).

Order

IT IS THEREFORE ORDERED by the Oklahoma State Board of Medical Licensure and Supervision as follows:


1. The license of J. Scot Wilson, Oklahoma medical license no. 17703, is hereby REVOKED.

2. Promptly upon receipt of an invoice for such charges, Defendant shall pay all costs of this action authorized by law, including without limitation, legal fees and investigation costs.
