ORDER GRANTING TERMINATION OF INDEFINITE PROBATION

This matter came on for hearing before the Oklahoma State Medical Board of Licensure and Supervision on March 6, 2014, at the office of the Board, 101 N.E. 51st Street, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board. Defendant, Paul Edward Wheeler, M.D., appeared in person.

The Board *en banc* heard testimony, reviewed the Motion and being fully apprised of the premises, entered the following Findings of Fact, conclusions of Law, and Orders:

Findings of Fact

- 1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and rules of the Board.
- 2. On January 29, 2009, after a hearing before the Board *en banc*, the Board entered an Order Granting Reinstatement of License Under Terms of Indefinite Probation filed herein on February 6, 2009.
- 3. Defendant is seeking to terminate the probation which commenced on January 29, 2009.
- 4. After hearing testimony the Board has determined that it is appropriate to terminate Defendant's indefinite probation.

Conclusions of Law

- 1. The Board has jurisdiction to reinstate the license of a physician pursuant to 59 O.S. §508.1
- 2. The Board may impose practice parameters and other restrictions as necessary to protect the health, safety and welfare of the public under 59 O.S. §480 et seq. The Board may also modify, or remove entirely, previously placed restrictions.

<u>Order</u>

It is therefore **ORDERED** by the Board of Medical Licensure and Supervision as follows:

1. Defendant's indefinite probation, the terms of which are described in the Order Granting Reinstatement of License Under Terms of Indefinite Probation filed herein on February 6, 2009, is hereby **TERMINATED**.
